On motion properly made and seconded, the Board directed the County Clerk to publish notice of the formation of Douglas County Sewer District No. 1.

NOTICE

PROPOSES SEWER DISTRICT IN WAKARUSA TOWNSHIP

WHEREAS, A petition has been filed with the County Clerk of Douglas County, Kansas, in accordance with Chapter 165 of the session Laws of 1927, and signed by I. C. Bushong; Geo. C. Sadd; Geo. J. Hood; Goldwin Goldsmith; William S. Johnson; Wm. M. Ege; Frank Strong; Mary Strong; Wm. A. McKeever; H. B. Hungerford; Dinamore Alter and Daniel H. Spencer, being the owners of fifty-one, or more, percent of the land acreage in the proposed district being described as follows:

Beginning at a point on the south line of the southwest quarter of section 36, Township 12 South, Range 19 East, 874.5 feet east of the Southwest corner of said quarter section; Thence 1438.7 feet east on center of road; thence North 660.9 feet; thence East 330.6 feet to center of road running North and South on East side of said quarter section; thence North along center of said road 660.9 feet to center of road running East and West along North half of said quarter section; thence west along the center of said road 1234.8 feet; thence South 550 feet; thence East 295 feet; thence South 314.7 feet; thence west 238 feet, more or less, to center of a road running North and South through the south half of said quarter section; thence South along the center of said road 455.4 feet to the point of beginning.

Be It Resolved, by the Board of County Commissioners of Douglas County, Kansas, in regular session assembled this second day of April, 1928, That, said proposed sewer, or sewers, will be of public benefit, and the boundaries of said benefit district being specifically set out, and the petition being in due and regular form;

Therefore, the County Clerk of Douglas County, Kansas, is hereby ordered to make publication of this proposed sewer district for three consecutive weeks in the official paper of Douglas County, and, if the owners of more than one-half of the property liable for taxation for the building of such sewer, disposal plants, pumping stations, pumps and other appurtenances, apparatus used in connection therewith shall not, within twenty days from such last publication file with the County Clerk their protests against such improvement, that County Commissioners shall have power to cause said sewer district formed and adequate sewers constructed therein.

Whereas, the governing body of the City of Lawrence, Douglas County, Kansas, has adopted a resolution providing for the improvement of East Fifteenth Street and the highway produced east therefrom beginning at the end of the present pavement on said East Fifteenth Street at its intersection with Barker Avenue in the City of Lawrence, thence east along the highway lying partly within the City of Lawrence and partly without the city of Lawrence to the east city limits located at the common corner between section 31 and 32, T 12, R 20; and sections 5 and 6, T 13, R 20, in Douglas County, Kansas; thence eastward for the distance of five-eighths of a mile, by paving said highway at a width of eighteen feet with such width at intersections, streets, roads or highways, as good engineering practice may require, the said paving to be constructed of concrete according to plans and specifications to be prepared by and engineer selected in the manner provided by law, and

Whereas, said resolution further provides that the same shall be submitted to the Board of County Commissioners of the County of Douglas, Kansas, for its adoption and further consideration and action as provided by section 12-647 to 12-655 inclusive, R. S. 1923, as amended by Chapter 100 of the Laws of 1927, and

Whereas, upon due consideration of said resolution by the Board of County Commissioners of the County of Douglas, Kansas, it is found that said resolution is in due form and the proposed improvement is a public utility and public necessity.

Therefore, BE IT RESOLVED by the Board of County Commissioners of the County of Douglas, Kansas, and it is hereby declared by said Board that the proposed improvement, to wit: the paving of East Fifteenth Street and the highway produced east therefrom beginning at the end of the present pavement on said East Fifteenth Street at its intersection with Barker Avenue in the City of Lawrence; thence east along the highway lying partly within the city of Lawrence and partly without the City of Lawrence to the east city limits located at the common corner between sections 31 and 32, T12, R20; and sections 5 and 6, T13, R20, in Douglas County, Kansas, thence east for the distance of five-eighths of a mile, the said highway to be paved or otherwise improved at a width of eighteen feet with such width of intersections, streets, roads,
