The Board of County Commissioners, of Douglas County, Kansas, consisting of G. E. Kretsinger, Chairman, X. J. Kennedy and D. L. Burton, Commissioners, met in annual sessions as a Board of Equalization for the purpose of reviewing the assess-ments of personal property and real estate improvements for the taxing year of 1928.
