I hereby certify that the foregoing resolution is, in all respects, except as here-after noted, identical with the final resolution for the improvement of US50 west from its intersection with US73W to the west Douglas County line. First exception; Description of read: Beginning at a point on the county read designated by the State Highway Commission as a proposed Federal Aid read, said point being the intersection of US 73 W with US 50, or the Northwest corner of the Northeast quarter sec. 2; T 15 S; R 19 B; and extending along said read in a west direction on the section lines to the Douglas-Osage county line, or the northwest corner of sec. 2; T 15 S; R 17 E; a distance of 12g miles, more or less. Second Exception: not to exceed-----per mile.

On motion properly made and carried the term of office of the County Health On motion properly made and carried the term of office of the County Health Physician was fixed at two years beginning June 1. 1928, or to correspond with the term of office of the City Health office, and the salary of the County Health officer was fixed at one hundred dollars per month, beginning with October 1, 1928. The Board of County Commissioners accepted the resignation of Dr. E. Keith as County Health Officer under the appointmnet of Jan. 10, 1927. The Board then appointed Dr. E. Keith for the term provided in the above recorded motion.
