Notice is hereby given that the Board of County Commissioners of Douglas County, Kansas, in regular session assembled did, on the 3rd day of July, 1929 levy a special assessment of \$----- against the following described real estate:

for the purpose of paying permanent road improvements, designated, Emery Road and West Hills Parkway and fully described in a petition filed in the office of County Clerk on March 5, 1928, and that the Board of County Commissioners will be in special session at their office in the Court House, Lawrence, Kansas, July 17, 1929 at 10:00 o'clock A. M., for the purpose of hearing complaints and making adjustments as they deem equitable.

Further notice is given that if the owner of any land within the benefit district shall pay the full amount assessed against such tract within Thirty Days after the date of this notice, such tract shall not be subject to any further annual assessment for such improvement.

The Board of County Commissioners met in adjourned regular session with all members and the County Clerk present. The Board completed the allowing of claims against the county for the month of June.

The Board ordered the following personal property tax of the 1928 cancelled:

J. W. Breyfogle \$26.64; Wayne Culp \$6.75; J. R. Cygon \$12.47; Geo. R. South \$2.34; Forrest D. Smythe \$33.03. The above were erroneous assessments.

In accordance with a Federal Court Judgment the following taxes were cancelled; Lawrence National Bank \$6173.73; Merchants National Bank \$6149.72; Watkins National Bank \$1664.05.

A cancellation of the 1928 tax in the amount of \$58.35 on the E. 25 A of NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ 5-12-20 was ordered. Also the penalties and advertising on tax sales #78, #79 of sale year 1928 amounting to \$9.23 was ordered cancelled.
