ORDER AND RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY KANSAS. allowing the petition for the improvement of the PLEASANT GROVE ROAD, of U. S. Highway No. 73 West Road.

September 1929 at a duly constituted and regular meeting of the Now, upon this 11th day of Board of County Commissioners of Douglas County, Kansas, and all members of said board being present, the petition for the permanent improvement of a certain road, known as the Pleasant Grove Road, comes up for final consideration and action; and the Board having caused to be published a notice in the Lawrence Daily Journal World, a newspaper of general circulation, on November 24, 1926, being at least ten days prior to the date of the meeting of this Board for the consideration of the petition and having carefully examined the said petition, and having carefully examined and caused to be examined the records of this county relating to the lands in said petition described, and after careful inquiry and full consideration, finds as follows: Road Part of UST3W
