Use chat from Baxter Springs Chat Co.
Use 600 cu. yds. chat per mile
Assuming chat weighs 2400 lbs. per cu. yd.
Freight rate from Baxter Springs to Baldwin is 7¢ per cwt.
Cost of hauling from Baldwin to job, 20¢ cu. yd. mile
Total length of road is 2 miles
Average haul for entire road is 2.3 miles
Cost per cu. yd. chat on the road
0.24 per cu yd. F. O. B. Baxter Springs
1.68 ,, Freight to Baldwin
0.25 ,, Shoveling from cars
0.46 ,, Haul of 2.3 miles
0.10 ,, Incidentals and overhead
\$2.75 per cu. yd. Unit cost of chat on the road

Gravel from Kowing Pit
Use 600 cu. yds. of gravel per mile
Total length of road is 17 miles
Average haul for entire road is 20.7 miles
600 cu. yds per mile x .7 equals 420 cu. yds. of gravel
420 cu. yds. x 20.7 miles equals 8694 cu. Yds. mile haul

Cost.

Hauling
8694 cu. yd. miles x 12¢ per cu. yd. mile equals \$1045.28
Gravel
420 cu. yds. x .15¢ per cu. yd. royalty 63.00
Handling & Misc
420 cu. yds. x .235¢ per cu. yd, Overhead 98.70
Total cost of entire road \$1204.98

\$1204.98 divided by .7 equals \$1721.40 average cost per mile of road
