The petition of free Gray and others for a road beginning at the quarter corner on the north line of section 31-13-19, a point in the present established sanded sec. 30-13-19, a distance of 3/4 mile, more or less, and terminating in the present esrablished road, was granted by the Board and the trustee of Clinton to the here of open said road, the road way to be 40feet wide lying wholly west and adjacent to

The petition of  $k_{ec}A_{ec}$ , Baldwin and others for the vacation of a road begining at the quarter corner on the south line of sec. 30-12-18, thenće north onemile and terminating at the quarter corner on the north line of sec. 30-12-18, is determined and ordered by the Board that the public good and convenience does require that the road as viewed be not vacated, but that permission is hereby granted to fence same until such time as the County Commissioners give notice to remove same.

The petition of H. E. Unger and others for the establishment of a road to run north from the patton Bridge on the section line, or as near thereto as possible, to a point where it would join the now established north and south county road being up for final action , it is determined and ordered by the Board that, owing to the excessive cost of the line petitioned for, final action be deferred until other possible routes can be investigated.

In the matter of the petition of W. L. Bwing and more than twelve others for the vacation of a road established "eb. 7, 1930, in Marion and Willow Springs Townships, and known as the Lone Star Rod and Gun Club road, fully described in the petition, the Board finds that the public good and convenience does require that haid road as viewed and located be not vacated.

C. s.p. washing machine for use at the County Farm Home. The motion was adopted, all commissioners voting ,Yes.

The petition for permanent improvement of the Wordsn-Range Line Road came befor the Board for consideration, and on motion of X, J, Keinedr, seconded by E. J. Hill, the County Clerk was directed to give notice that the Board would give a hearing to said petitioners on January 7, 1951, at 2 o'clock P. M. at their office in the city

The Board of County Counissioners entered into a contract with Fred E. Torneden in which Douglas County is given the exclusive rights for a period of five years to all of the sand-gravel deposit located in the South 75 acres of the NW2 of Section 21-13-18

On motion properly made and seconded, it was ordered by the Board of County Commission Commissioners that of the total sum of \$16, 647,93 paid by the State Highway Commiss-ion on State Highways for the year 1930, \$12,590.61 be credited to Fort to Fort Bond interest; #I349.61 be credited to U. S. HSW Bond and Interest Account, and that the County Clerk issue to taxpayer entitled thereto special refund warrants against the balance as 1930 refund of the State Highway Commission.
