In the years 1927, 1928, 1929, it being understood and magreed that the County of Douglas shall in each year advance all special taxes to the City of Lawrence, charging all uncellected special taxes to said city of of Lawrence at the end of said tax year, and giving credit to said City of Lawrence -for all special taxes which may be collected from time to time. That it is resolved that upon approval of this resolution and acceptance threof by proper resolution of the Board of County Commissioners of Douglas County, Kansas, this resolution shall become binding upon the City of Lawrence and the County of Douglas , State of Kansas.
