September 10, 1932

The Board of County Commissioners met in adjourned regular session with all members and the County Clerk present. The Board completed the allowing of claims against the county for this session.

The Board spent the afternoon in making an unofficial view of a propose road in Section 2, T13S, R18E.

To Fred Moorman on a valuation of \$270 on the S 50 feet of the W 125 feet of Lot 11, Block 3, South Lawrence. 1930 refund, \$9.81; 1931 refund, \$9.35; Total \$19.16

FINAL ORDER OF THE BOARD OF COUNTY COMMISSIONERS ON THE PETITION OF G, A, DREYER

The petition of G, A, Dreyer and others for the location of a road beginning at a point in the section line between Sections 1 and 2, T12S, R17E, 1670 feet South of the quarter corner between said sections, said point also being a point in o;d road No. 107, thence North on line between said sections to the quarter corner between said sections and terminating therein, and also to vacate all portions of old road No. 107 and 358 as lies between point of beginning and point of ending of road to be located, being before the Board for consideration and final action, it is hereby ordered by the Board of County Commissioners that said petitioned road shall be laid three rods wide on the west land line and that G. W. Dreyer be and is hereby awarded land damages in the sum of \$50.00, and that the old road as lies between the point of beginning and the point of ending of the new located road. It is also ordered that a drainage ditch be opened eastward to the creek on right of way beginning at the quarter corner between said sections 1 and 2. T12S, R17E.
