

COMMISSIONER'S RECORD M

October 5, 1932

The Board of County Commissioners met in adjourned regular session with X. J. Kennedy, Chairman, and Earl T. Black, Commissioner, and the County Clerk present, Commissioner E. J. Hill being ill. Claims against the county were presented and allowed as per Allowance Register. No other business of record was transacted at this meeting.

October 8, 1932

The Board of County Commissioners met in adjourned regular session with X. J. Kennedy, Chairman, Earl T. Black, Commissioner, and the County Clerk present, Commissioner E. J. Hill being ill. The only business of record at this meeting was the allowing claims against the county.

October 12, 1932

The Board of County Commissioners met in adjourned regular session with X. J. Kennedy, Chairman, Earl T. Black and E. J. Hill, Commissioners, and the County Clerk present. Commissioner Hill was compelled to leave on account of illness.

The case of John Stutz vs. Board of County Commissioners came up for hearing in the District Court and most of the day was spent in court.

The Board completed the allowing of claims for this session, and then adjourned to October 22, 1932.

October 22, 1932

The Board of County Commissioners met in session as per adjournment of October 12, 1932, with X. J. Kennedy, Chairman, and Earl T. Black, Commissioner, and the county clerk present. Commissioner Hill was absent on account of illness.

The Board approved the Federal Emergency Relief proposals as to the following projects: Project No. 16-7, improvement of Lime Kiln Road and project No. 16-8, improvement and repair of Emory Road and University drive. The Chairman and County Clerk were authorized to sign the necessary requests for funds to pay for labor on these projects.

The Board together with the County Engineer and the County Clerk investigated the proposal to open a township road on the North section line of Sections 2 and 3, T19S. R18E in Kanwaka Township.

The foregoing minutes for the month of October were read and approved this 7th day of November, 1932.

November 7, 1932

The Board of County Commissioners approved the application of Flora Huffman of Lawrence for admission to the State Sanatorium for Tuberculosis at Norton, Kansas.

November 12, 1932

The Board of County Commissioners met in adjourned regular session with X. J. Kennedy, Chairman, Earl T. Black, Commissioner, and the County Clerk present. Commissioner E. J. Hill being absent on account of illness. No business of record, other than the allowing claims, was transacted at this meeting.

November 16, 1932

The Board of County Commissioners met in adjourned regular session with X. J. Kennedy, Chairman, Earl T. Black, Commissioner, and the County Clerk present, Commissioner E. J. Hill being absent on account of illness.

The Board of County Commissioners acting under Chapter 68, Article 114, Laws of 1923, issued their order vacating and relocating township roads as follows:

Read in section 12, T14S; R19E, Willow Springs Township;

Read in section 6, T12S, R19E, Leecompton Township;

Township road #370 in and between sections 34 and 3 on township line between Townships 12 and 13, R18E; in Kanwaka Township.

The Board also ordered that the preceding, surveys and plats of said ordered roads be recorded in the road records of the county. It was also ordered that the trustees of the respective townships be directed to proceed under this order to prepare said ordered roads for public travel.

The minutes of the meetings held during the month of November, 1932 were read and approved this day of December, 1932.
