

Beginning at a point six hundred and sixty feet (660) South of the stone monument marking the North west corner of the North east $\frac{1}{4}$ Section 1, T 13 S, R. 19 E; thence South along the North and South center line of said Sec. 1, three hundred and ninety six (396) feet; thence East Eleven hundred and three and five tenths feet (1103.5) to the stone monument marking the North west corner of the University Place Addition; thence North three hundred and ninety six feet (396); thence West Eleven hundred and three and five tenths feet (1103.5) to the place of beginning.

Also the West five hundred and three tenths feet (500.3) of the following: Commencing twenty five (25) chains North of a point twenty two and seventy five hundredths (22.75) chains West of the South east corner of the South east $\frac{1}{4}$, Sec. 36, T 12 S, R 10 E, and running thence East to the West line of Mississippi Street a distance of twelve and forty seven hundredths (12.47) chains; thence North along the West line of Mississippi Street ten (10) chains, to a point twenty (20) rods South of the North line of said $\frac{1}{4}$ Sec; thence West twelve and forty seven hundredths (12.47) chains; thence South ten (10) chains to the place of beginning.

NOTICE BY THE BOARD OF COMMISSIONERS OF DOUGLAS COUNTY
KANSAS OF A HEARING TO CONSIDER THE ADVISABILITY OF ADDING
ADDITIONAL TERRITORY TO THE CITY OF LAWRENCE, KANSAS.

WHEREAS, the City of Lawrence, Kansas, has submitted to this Body a Petition submitted under Article Five (5) of the 1931 Supplement to Revised Statutes of Kansas for 1923, in which said City seeks to add within its boundaries the following described property: to-wit:

Beginning at a point three hundred thirty (330) feet south, and seven hundred fifty eight and five tenths (758.5) feet east of the North west corner of the South east $\frac{1}{4}$ of Sec. 36 - T 12 S-R 19 E; thence west seven hundred fifty eight and five tenths (758.5) feet to the west line of the South east $\frac{1}{4}$ of said Sec. 36; thence south on the west line of said $\frac{1}{4}$ Sec. Sixteen hundred fifty two and two tenths (1652.2) feet; thence west three hundred thirty one and one tenth (331.1) feet; thence south six hundred sixty two and three tenths (662.3) feet; thence east three hundred thirty and six tenths (330.6) feet to the Southwest corner of the Southeast $\frac{1}{4}$ Sec. 36, T 12 S-R 19 E; thence south six hundred sixty (660) feet; thence east eleven hundred thirty one and five tenths (1131.5) feet; thence north six hundred sixty feet to the north line Sec. 1 T 13 S-R 19 E; thence north ten hundred twenty one and five tenths (1021.5) feet; thence east five hundred and three tenths feet (500.3) on the south line of Thirteenth Street projected west, to a point ten hundred one and twenty two hundredths feet (1001.22) west of the East line of Sec. 36-T 12S-R 19E; thence north parallel to Mississippi Street, six hundred eighty eight (688) feet; thence west five hundred and three tenths (500.3) feet; thence north six hundred sixty (660) feet; thence west three hundred eighty nine and six tenths (389.6) feet to the point of beginning.
