A motion was moved and properly seconded that the hour scale of wages for Miss Isabelle Keeler in the Treasurer's office be fixed at 40¢ per hour; and that of Mrs Marvin LeSuer, bookkeeper working in the Treasurer's and the County Clerk's Offices, be fixed at 65¢ per hour.

The Board of County Commissioners met in an adjourned regular session at 9:30 A. M. with James F. Brass, Chairman; Earl T. Black, Commissioner; Chris Schaake, Commissioner; and U. S. G. Plank, County Clerk present.

Further bills for the month were presented, approved, and ordered paid.

The application for two patients to be sent to the State Sanatorium for Tuberculosis at Norton, Kansas was presented by Poor Commissioner Mary Jamison on the recommendation of Health Officer H. Penfield Jones. On motion by Earl T. Black, seconded by Chris Schake, the application of Grace Nevieu for entrance to the hospital was unanimously voted. The County agreed to pay transportation one way, expences for entry into the hospital, and a fee of one dollar a day. On motion by Chris Schake, and seconded by Earl T. Black it was voted that Harry Hough be sent to the State Sanatorium for Tuberculosis at Norton, Kansas on the condition that the County pay transportation one way, expences for entry into the hospital, and a fee of one dollar a day.

A delegation of citizens from Willow Springs Township headed by L. A. Florg appeared before the Board to discuss with the Board a proposition to rock the road beginning at Worden and going south to the County Road and then east on the County Road to 73 W.

A delegation from Kanwaka Township headed by Ralph Coleman appeared before the Board and presented their claims for the rocking of two miles of road beginning at a point on highway 40 at the southwest corner of 30-12-19, forth to a point known as "Coleman" Corner. The committee was well received; but no action was taken.

A representative from the Burrough Adding Machine Company from Topeka, Kansas appeared before the Board in company with representatives of the Relief Work under the direction of Miss Mary Jamison, and presented the claims of the relief workers for an adding machine. After a demonstration and some considerations a machine was bought for the relief department at a cost of \$207.00-\$20.70 cash and the balance of \$186.30 in nine equal installment payments with 6% interest on unpaid balances.
