

COMMISSIONER'S RECORD M

WHEREAS: The county engineers of the respective counties have recommended that said bridge is in need of immediate repairs and estimate the cost of said repairs at \$30,000.00 and

WHEREAS: The road and bridge funds of said counties are not sufficient to make said repairs:

THEREFORE BE IT RESOLVED: By the Board of County Commissioners of Leavenworth and of Douglas Counties of the State of Kansas, in joint meeting assembled, that application be made to the 1935 Legislature of the State of Kansas, for authorization of a bond issue in the sum of Thirty Thousand Dollars (\$30,000.00) for the purpose of repairing the bridge across the Kansas River at Eudora, Kansas; each county to issue 50% of said bonds and to pay 50% of the cost of the repairs agreed upon; said bond issue to be retired by a levy on all tangible properties in said counties. Any money that may be obtained from the Federal Government for the purpose of repairing said bridge shall be used in lieu of the money raised by the sale of bonds as specified above and in such case only the balance of the cost shall be paid by the issue of bonds.

Moved by H. C. Short and seconded by Earl T. Black, that the resolution be adopted. It was so ordered by an unanimous vote.

The Board of County Commissioners met in an adjourned regular session with James F. Brass, Chairman; Earl T. Black and Chris Schaeke, Commissioners; and U. S. G. Plank, County Clerk present.

The minutes of the county clerk for the January 14th, and January 18th, meetings were read and approved.

The remainder of the bills for January were presented, allowed, and ordered paid.

Fred Gregory and the Kanwaka Township Board appeared before the Board of County Commissioners in interest of the Gregory Road. The Board listened attentively without taking any definite action.

Ed. Steel and William Johnson appeared before the Board praying that the County will take over what is known as the Sigel Road. The Board listened attentively without taking any definite action.

Joseph J. Svoboda and a number of other Lecompton Township residents appeared before the Board of County Commissioners, praying that the road from Lecompton west and thence southwest, connecting with Highway 40 be further graded and rocked. No specific action was taken.

C. E. Bussing appeared before the Board. His interests were in a bridge on Mud Creek just north of Midland Station on Highway 10.

A petition was presented by Poor Commissioner Mary Jamison, and approved by Health Commissioner H. Penfield Jones asking that the Board of County Commissioners send Albert Franklyn Conroy to the State Sanatorium at Norton, Kansas to be treated for Tuberculosis. On a motion and a vote, Albert F. Conroy was ordered to the Sanatorium. The county to pay transportation one way, entrance costs, and a fee of one dollar per day.

Mrs. W. O. Nelson, C. H. Pringle, Sheriff Fred Vogler, and Henry Smith City Policeman, appeared before the Board presenting the claim of Otto Vollenzein for hospitalization in Bell Memorial Hospital to be operated upon for "Knee Cap" injury and to be cared for by Dr. Francisco, bone specialist. After some discussion the Board voted unanimously to send Otto Vollenzein to Bell Memorial Hospital at the expense of the County, and said expenses to be met by the Board up to and including eight weeks if necessary.

Doctors H. L. Chambers, W. O. Nelson, V. M. Guchard, and A. M. Fortney representing the medical fraternity of Douglas County appeared before the Board suggesting a plan for co-operation between the medical fraternity of Douglas County and the Board of County Commissioners relative to the medical care of persons on county relief rolls. No specific action was taken on their suggestions.

County Clerk U. S. G. Plank presented to the Board of County Commissioners the names of the applicants to do the personal property assessing for the assessing period of 1935. From the number of names suggested the following were chosen and approved by the Board:
