The Board of County Commissioners met in regular adjourned session with all the members of the Board present including the County Clerk. Doctors W. O. Nelson, H. L. Chambers, and V. M. Auchard representing the Douglas County Medical Association met with the Board to renew the discussion of the question touching on the care of Douglas County citizens who are now on the relief roll. The question was discussed at some length without any definite action taken.

The Board authorized County Engineer E. E. Trueblood to move a county rock crusher to the CCC camp at Lone Star for the use of the authorities in charge of the camp for rock crushing purposes. Authority was given for the use of the crusher for a period of ten days.

The Board authorized County Treasurer, S. S. Learned to purchase a long table suitable for the work of the Treasurer's office at a price fixed at \$46.00.

The claims of Dr. G. W. Jones and Lillie E. Brown on moneys allegedly due them from tax refunds were again presented to the Board through their agent John Tucker and touching on these claims, the Board passed the following resolutions:

A resolution of the Board of County Commissioners of Douglas County, Kansas in reference to a claim of Dr. G. W. Jones for refund of taxes paid on real property,

WHEREAS, one Dr. G. W. Jones is the owner of the following described property to-wit:

Lot number three (3), the east eight feet of lots number four (4) and five (5) and six (6) and all of lots number one (1) and two (2), less that part of said lots embraced within the following tract: beginning sixteen (16) feet east of the northwest corner of said lot number one (1), thence east one hundred and twenty-eight (128) feet; thence south fifty (50) feet; thence west one hundred twenty-eight (128) feet; thence north fifty (50) feet, to the place of beginning, all in block fifteen (15) Lane's second addition to the City of Lawrence. Also lot number one (1), the north half of lot number two (2), the east eight feet of lot number twelve (12), and the east eight feet of the north half of lot number eleven (11), all in block two (2), Oread addition, an addition to the City of Lawrence, Douglas County, Kansas, and

WHEREAS, the said G. W. Jones paid the taxes assessed against the said property the years of 1930 and 1931 in the amount of \$706.27 to the Treasurer of Douglas County, Kansas, and

WHEREAS, the said Dr. G. W. Jones failed to pay said taxes under protest, and

WHEREAS, the said Dr. G. W. Jones has made a claim for refund of said taxes to this Board,

NOW THEREFORE BE IT RESOLVED, by the Board of the Commissioners of Douglas County, Kansas in regular meeting assembled, that the said claim of \$706.27 by the said Dr. G. W. Jones be denied for the reason that the said G. W. Jones failed to pay said tax under protest as provided by law.
