The Board of County Commissioners met in an adjourned regular session with all the Commissioners and the County Clerk present. Carl Hird, Ed. Shaw, Charles Topping, and others met with the Board and presented their respective claims for the lands that would be taken if the O'Mera road was brought to the required width. No action for record was taken. Other parties met with the Board for informal discussions, mostly matters pertaining to roads. In the afternoon an effort was made to complete the allowance of monthly bills.

The Board adjourned to meet at 9:30 a. m. March 13, 1935.

March 13, 1935

The Board met in an adjourned regular session with all the Commissioners and the County Clerk present. The final amount of bills for the month of February were scrutinized, passed and ordered paid.

The dental society of Douglas County was represented before the Board by a committee of its members. The members of the committee were: Drs. Bumgardner, Kennedy, Kibler, and Lindemberger from Lawrence and Dr. Flickenger from Baldwin City. The object of the meeting was to arrive at some equitable understanding as to the charges for dental work for the citizens on relief in Douglas County. The question was well discussed with the committee. A motion was made and seconded that a scale of prices for the pulling of teeth be established at \$1.00 for the first tooth pulled and 50¢ for each succeeding tooth pulled. The vote for this motion was unanimous.

Other delegations met with the Board the most important of which was a delegation from Kanwaka renewing the talk relative to acquiring land for the O'Mera road. Again no action for purposes of record was taken.

No further business appearing the Board adjourned to meet on the morning of March 15 at 9:30 o'clock.

The Board of County Commissioners met in adjourned session at the appointed hour with all the members of the Board and the County Clerk present. The Board submitted its final report on the Otto Johanning road petition. The report follows:

WE, THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, KANSAS

Acting as VIEWERS of a road petitioned for by Otto Johanning and others of Kanwaka TOWNSHIP, met, as heretofore determined and ordered by the Board, at the beginning point of the road as petitioned for to be altered and vacated on the 8th day of March 1935 and proceeded to view the route of said road as prayed for in the petition, or as nearly so as we consider a good road can be made at a reasonable expense, taking into consideration the utility, convenience, inconvenience, and expense which will result to individuals as well as to the public if said road or any part thereof be altered-vacated-opened for public use.

Further action and hearing on the petition was postponed to the 13th day of March 1935 at which date interested parties were notified to appear.

Therefore no objections to the changes petitioned for on this road and no damages claimed for land taken, therefore we recommend the petition be granted.

The route of said road was surveyed under our direction by E. E. Trueblood County Surveyor assisted by C. E. Redmond and Albert Cox chairmen and Edgar Duver marker. The report of survey, plat and field notes are hereto attached and are made part of this report and record of final action.
