April 10, 1935

The Board of County Commissioners met in regular adjourned session with all the members of the Board and the County Clerk present. The minutes of the meetings for the month of March were read by the County Clerk, corrected and approved as corrected.

An application from one Susie F. Davis of 925 Delaware Street, Lawrence, Kans. was presented in regular form with the approval of County Health Officer H. Penfield Jones, for admission to the State Sanatorium for Tuberculosis at Norton, Kansas. The case was referred to County Case Worker Mary E. Jamison for investigation.

Miss Jamison reported to the Board that the governing body of the Congregational Church of Lawrence had tendered the use of quarters in the church for sewing room purposes.

Moved by Earl T. Black and seconded by Chris Schaake that this Board extend to the Congregational Board its thanks for the use of the quarters tendered and to assure them that any added expenses for gas and electricity accruing to the Church Board will be met by the Board of County Commissioners.

Moved, seconded and voted that the Board pay for typewriter ribbons used in the Relief Department on such machines that are owned by the county.

On motion properly seconded and unanimously voted the Board authorized certain alterations and repairs in the County Treasurer's Office to the extent of \$773.76. The contract was awarded to Samuel Dodsworth Company, represented by W. H. McKone.

A request for clothing for patients in the Hospital for Epileptics at Parsons, Kansas was presented to the Board. The request was referred to the Commissioner of the Poor with instructions that the clothing be furnished from here rather than purchased at the institution.

The Board adjourned.

At a called meeting of the Board of County Commissioners, said meeting having been called by the County Clerk U. S. G. Plank, all the members of the Board and the County Clerk were present. County Attorney R. B. Stevens, and by invitation Attorney J. B. Wilson were also present.

The purpose of the meeting was to pass upon the payment of a claim presented by the Clerk of the District Court satisfying a judgment against the County under Judgment No. 15905 G. W. Jones in the sum of \$706.27 and another Judgment No. 15906 Lillie E. Brown in the sum of \$261.65. After the question of the judgment had been discussed and all points properly clarified the subject matter was disposed of in a motion by Chris Schaake. The motion follows:

In compliance with Court Judgment against the County of Douglas favoring Lillie E. Brown in the sum of \$261.65 and favoring G. W. Jones in the sum of \$706.27 I move that the judgments be recognized by the Board of County Commissioners and ordered paid.

The motion was seconded by Earl T. Black and put by Chairman James F. Brass. All three Commissioners voted aye.

No further business of record appearing before the Board the meeting was adjourned.
