The Board of County Commissioners met in continued special session for the purpose of reviewing specifically item by item and finally, as a whole, the transcript in connection with the issuing of the \$50,000.00 Bond Issue as allowed under House Bill No. 427. Commissioners James F. Brass, Chairman, and Chris Schacke and Earl T. Black, Commissioners, U. S. G. Plank, County Clerk, S. S. Learned, County Treasurer, Mildred Le Suar, Pockkeeper, and R. B. Stevens, County Attorney present.

County Clork, U. S. G. Plank presented the transcript above mentioned which transcript follows:

April 6, 1935

The Board of County Commissioners of Douglas County, Kansas met in regular adjourned session on this 6th day of April, 1935, with James F. Brass, Chairman, Earl T. Black and Chris Schacke, Commissioners and U. S. G. Plank, County Clerk, present. Whereupon, it was moved by Commissioner Chris Schacke and seconed by Commissioner Earl T. Black that the following resolution be adopted:

RESOLUTION

WHEREAS, the Board of County Commissioners find that the combined tax levies of one mill for County Poor Fund and five-eights of a mill for the Emergency Poor Relief Fund will not be sufficient to meet the nocessary expenditures for the year 1935, the Emergency Relief fund already being depleted; and

WHEREAS, under Section 2, House Bill 427, Session Laws of 1935, it is Provided that the County may issue bonds for the relief of the poor mattexceeding one-third of one per cent of the county's assessed valuation;

NOW THEREFORE, Be it resolved by the Board of County Commissioners of Douglas County, Kansas, in adjourned regular session this 6th day of April, 1935, that the Board draw a Resolution for the issuance of bonds for the relief of the poor and prosent it with a formal Application to the State Tax Commission for authority to issue bonds as provided in Section 2 of House Bill 427. Session of 1935.

RESOLUTION

FOR THE ISSUANCE OF BONDS FOR THE RELIEF OF THE POOR AS PROVIDED IN SECTION TWO OF HOUSE BILL 427 LEGISLATIVE SESSION OF 1935.

WHEREAS, it appears to this Board an additional revenue will be needed for the relief of the poor and destitute of the County of Douglas, State of Kanses, and that the funds on hand for said purpose will be inadequate for the care of the poor and destitute and,

WHEREAS, the County of Douglas had in year preceding an assessed valuation of \$38,885,519; and

WHEREAS, under Section 2, House Bill 427, Session Laws of 1935, it is provided that the County may issue bonds for the relief of the poor not exceeding 1/3 of 1 per cent of said assessed valuation,

NOW THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Douglas County, Kansas, in adjourned regular session this 6th day of April, 1935, that pursuant to House Bill 427, the County of Douglas issue bonds in the sum not to exceed FIFTY THOUSAND DOLLARS (\$50,000.00) the same to mature in equal amounts each year for a period not exceeding ten years, the said County to annually make a levy covering the interest accruing and the bonds maturing during the next budget year.
