of County Commissioners of Douglas County, Kansas, as said coupons severally become due, both principal and interest of this bond being payable at the office of the State Treasurer of the State of Kansas, in the City of Topeka, Kansas, And said County of Douglas, in the State of Kansas, is held and firmly bound by these presents, and the full faith, credit and resources of said county are hereby irrevocably pledged for the prompt payment of said principal and interest at maturity.

This bond is one of a series of one hundred bonds of like date and tenor, excepting maturity, aggregating the principal sum of \$50,000.00 issued by said County for the purpose of relief of the poor in said County as prescribed by law. And it is hereby certified and recited that this bond is issued in full conformity with the provisions, restrictions and limitations of the Constitution and laws of the State of Kansas and is authorized and issued under authority of of Section 2 of House Bill 427, Legislative Session of 1935 of the Kansas Legislature and of Article 1 of Chapter 10, R. S. 1923 of Kansas, and all acts amendatory thereof and pursuant to all other laws of said state applicable thereto, and pursuant to the resolutions of the Board of County Commissioners of Douglas County, Kansas, and this bond and all other bonds of said series and all interest thereon, are to be paid by said Douglas County, Kansas.

And it is hereby declared and certified that all acts, conditions and things required to be done and to exist precedent to and in the issuance of this bond have been properly done and performed and do exist in due and regular form and manner as required by the Constitution and laws of the State of Kansas, and that the total indebtedness of said county, including this series of bonds, does not exceed any constitutional or statutory limitation.

IN WITNESS WHEREOF, the said County of Douglas, in the State of Kansas, by its governing body has caused this bond to be signed by the Chairman of the Board of County Commissioners, and attested by the Clerk of said Board and the seal of said County to be affixed hereto, and the coupons hereto attached to be signed with the facsimile signatures of said officers, and this bond to be dated this 1st day of May, 1935.
