

To the Board of Commissioners of
Douglas County, Kansas

PETITION FOR THE ORGANIZATION OF THE SOUTH SIDE KAW DRAINAGE DISTRICT

We, the undersigned persons, constituting two-fifths of the resident tax payers of the herein described territory, being either tax payers residing in said territory or tax payers residing in Douglas County, Kansas and owning land in said territory, hereby Petition the honorable Board of Commissioners of Douglas County, Kansas to organize and incorporate a drainage district as provided in Article 4 of Chapter 24, Revised Statutes 1923, and as since amended, which said lands herein described and embraced in said description are subject to injury and damage from the over-flow of waters from the Kansas and Wakarusa Rivers, and that the improvement of the channel of said water courses, the construction and maintenance of levies, drains or other works are necessary to prevent such over-flow; and that such improvement or works will be conducive to the public health, convenience and welfare.

Said territory is hereby described as follows, to-wit:

EUDORA TOWNSHIP:

Beginning at a point on the southerly bank of the Kansas River at low water mark, and on the section line between Sections 26 and 27, Township 12 S., Range 21 E of the 6th Principal Meridian; thence, southerly along said section line to the S. E. Corner of the N. E. $\frac{1}{4}$ of the S. E. $\frac{1}{4}$ of Section 34, thence westerly along the southerly boundary of said subdivision to the S. W. corner thereof; thence northerly along the westerly boundary of said subdivision to a point where it intersects the northerly boundary of the right-of-way of the Atchison, Topeka and Santa Fe Railway Company; thence westerly along the northerly boundary of said right-of-way through sections 34, 33, and 4 to a point where it intersects the southerly bank of the Kansas River at low water mark; thence easterly along the southerly bank of said river through sections 4, 33, 28 and 27, Township 12 S., Range 21 E to the point of beginning.

WAKARUSA AND EUDORA TOWNSHIPS:

Beginning at a point on the southerly bank of the Kansas River at low water mark, and on the northerly boundary of the right-of-way of the Atchison, Topeka and Santa Fe Railway Company in Section 4, Township 13 S., Range 21 E of the 6th Principal Meridian; thence westerly along the northerly boundary of said right-of-way through sections 4, 5 and 6 to a point where it intersects the section line between sections 1 and 6; thence northerly along said section line to the township corner common to Township 12 S., Range 20 E; Township 12 S., Range 21 E; Township 13 S., Range 21 E; and Township 13 S., Range 20 E; thence westerly along the township line to the $\frac{1}{4}$ section corner common to sections 33 and 4 of Township 12 S., Range 20 E, and Township 13 S., Range 20 E; thence southerly along the north and south center line of Section 4 to a point where it intersects the northerly boundary of the right-of-way of the Atchison, Topeka and Santa Fe Railway Company; thence westerly along the northerly boundary of said right-of-way through sections 4, 33, 32 and 31 to the subdivision line between the east $\frac{1}{2}$ and the west $\frac{1}{2}$ of the N. E. $\frac{1}{4}$ of Section 31, Township 12 S., Range 20 E; thence northerly on said subdivision line to a point where it intersects the southerly boundary of the Kansas River at low water mark; thence easterly along the southerly boundary of said river and through sections 31, 32, 33, 34, 27, 26 and 25 of Township 12 S., Range 20 E., and Sections 31 and 32 of Township 12 S.; Range 21 E; and Sections 5 and 4 of Township 13 S., Range 21 E. to the point of Beginning.

WHEREFORE these petitioners pray that all of the territory within the boundaries defined in this Petition be incorporated as a Drainage District to be known as the SOUTH SIDE KAW DRAINAGE DISTRICT, and that this Board approve this Petition, and fix a time for a hearing thereon, five days after the Notice provided for in Section 24-404 Revised Statutes, 1923.
