

COMMISSIONER'S RECORD M

River at low water mark, and on the northerly boundary of the right-of-way of the Atchison, Topeka and Santa Fe Railway Company in Section 4, Township 13 S., Range 21 E of the 6th Principal Meridian; thence westerly along the northerly boundary of said right-of-way through sections 4, 5 and 6 to a point where it intersects the section line between sections 1 and 6; thence northerly along said section line to the township corner common to Township 12 S., Range 20 E; Township 12 S., Range 21 E; Township 13 S., Range 21 E; and Township 13 S., Range 20 E; thence westerly along the township line to the section corner common to sections 33 and 4 of Township 12 S., Range 20 E, and Township 13 S., Range 20 E; thence southerly along the north and south center line of Section 4 to a point where it intersects the northerly boundary of the right-of-way of the Atchison, Topeka and Santa Fe Railway Company; thence westerly along the northerly boundary of said right-of-way through sections 4, 33, 32 and 31 to the subdivision line between the east and the west of the NE $\frac{1}{4}$ of Section 31, Township 12 S., Range 20 E; thence northerly on said subdivision line to a point where it intersects the southerly boundary of the Kansas River at low water mark; thence easterly along the southerly boundary of said river and through sections 31, 32, 33, 34, 27, 26 and 25 of Township 12 S., Range 20 E., and Sections 31 and 30 of Township 12 S., Range 21 E; and Sections 5 and 4 of Township 13 S., Range 21 E to the point of beginning.

The aforesaid described territory to constitute a corporation and the inhabitants within such bounds are hereby incorporated as a Drainage District under the name of THE SOUTH SIDE KAW DRAINAGE DISTRICT OF DOUGLAS COUNTY, KANSAS.

IT IS FURTHER ORDERED BY THE BOARD that the time and place of holding the first election to choose officers for such Drainage District be set and fixed as follows, to-wit:

On the 12th day of October, 1935, between the hours of 8 A. M. and 6 P. M. in the following named place, Farmland District School House No. 71, situated within said Drainage District as heretofore described.
