

COMMISSIONER'S RECORD M

October 7, 1935

The Board of County Commissioners met in regular session with James F. Brass, Chairman, Earl T. Black and Chris Schaake, Commissioners, and U. S. G. Plank, County Clerk present.

The bills for salaries, wages, labor, material for the county and for the maintenance of the Poor were presented, scrutinized, and ordered paid as per allowance record.

The regular meeting of the Board of County Commissioners this 7th day of October, 1935, assembled comes on for consideration the approval of the bond of the Treasurer of Douglas County.

It is now moved by Earl T. Black that the bond of the Treasurer as provided by Section 19-501 R. S. 1923, be fixed at \$50,000.00. Said motion now seconded by Commissioner Chris Schaake, and it being unanimous vote of all the Commissioners the said motion be adopted, it is now so ordered.

The motion was now made by Earl T. Black that the Surety Bond now offered by the Continental Casualty Company in the sum of \$50,000.00 for and on behalf of the Treasurer of Douglas County be now approved. This motion was seconded by Commissioner Chris Schaake, and it being unanimous vote of the Board of County Commissioners, the motion be adopted, the same was now ordered.

RESOLUTION

WHEREAS the Bond of Arthur Gardner, Treasurer of Douglas County is now being accepted and approved, and

WHEREAS as provided in Chapter 75, Session Laws of 1935, certain banks shall be designated as depositories, and

WHEREAS the Lawrence National Bank of Lawrence, Kansas, the Baldwin State Bank of Baldwin, Kansas, First Savings Bank of Lawrence, Kansas, the Kaw Valley State Bank of Eudora, Kansas, The State Bank of Leocompton, Leocompton, Kansas, the First National Bank of Lawrence, Kansas, and the Peoples' State Bank, Lawrence, Kansas, have filed their schedules showing that they have deposited security to the amount of 70% of the amount which may be on deposit in said banks as required by said Chapter 75, Session Laws of 1935,

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas in regular meeting assembled this 7th day of October, 1935, that the following named banks be designated as depositories of public funds:

The Lawrence National Bank of Lawrence, Kansas.
The Baldwin State Bank of Baldwin, Kansas.
The First Savings Bank of Lawrence, Kansas.
The Kaw Valley State Bank of Eudora, Kansas.
The State Bank of Leocompton, Leocompton, Kansas.
The First National Bank of Lawrence, Kansas.
The Peoples' State Bank of Lawrence, Kansas.

BE IT FURTHER RESOLVED that the itemized statement furnished by said depositories banks on this date showing the schedule of securities deposited with this Board be now accepted and approved as in conformity with Chapter 75, Session Laws of 1935.

In Re: Eudora Kaw River Bridge Bonds. The Estes, Payne and Company, brokers, represented by Donald A. Seltman of Lawrence, appeared before the Board with an offer of par and accrued interest on the \$15,000.00 issue of the above named bonds by Douglas County. It is now moved by Earl T. Black and seconded by Chris Schaake the the County Board of Douglas County accept the offer of the above bonding company and by unanimous vote, all the Commissioners voting, it was so ordered.

The question of renewal of the Douglas County Audit contract of the J. E. Caton Company of Topeka, Kansas came before the Board. Allen French, representing the above named company, offered to renew a contract from October 1, 1934 to October 8, 1935 for the auditing of the Treasurer's books, and all other officers' accounts to be audited from January 1, 1935 to December 31, 1935 for the sum of \$400.00. By unanimous vote of the Board, the offer was accepted and a contract was entered into by both parties interested therein.

George Docking, in the interest of the First National Bank, asked that the taxes for 1931 on the property described as: Beginning 225' of NW cor Hancock and Ohio N 75' W 125' S 75' E 125', which he had paid under protest because the property had been occupied by an fraternity for the year 1931 be cancelled. On motion by Chris Schaake and a second by Earl T. Black and a vote of the Commissioners, all being present, it was ordered that a refunding warrant for \$259.88 be issued to George Docking. It was so ordered.

The County Clerk was authorized to increase the amount of bank burglary and robbery
