October 31, 1935

A special meeting of the Board of County Commissioners was called by the Chairman James F. Brass, for the purpose of meeting with the members of the Douglas County Relief Committee. At said meeting, all the Commissioners and the County Clerk were present. In addition to the two members of the Board, Earl T. Black and James F. Brass, who are members of the Relief Committee, George Hedrick, John Selig, Ray Ogden, other members of the committee were present.

The subject under consideration was Bulletin No. 277, sent out from those in charge of KERC at Topeka. This bulletin provoked considerable discussion, which discussion was disposed of in a motion made by Earl T. Black and seconded by Chris Schaake, which motion follows:

Moved that the Douglas County Relief Committee ask that those in charge of the KERG in Topeka, allow Douglas County to continue with the present Poor Commissioner, Harold T. Baker, and with the present Case Supervisor, Abbie Langmaid, until such time as the Committee is unable to comply with the requirements of Bulletin No. 277; the motion was put by the Chairman and it became a vote--all Committee members voting "yes".

Meeting adjourned.

November 4, 1935

The Board of County Commissioners met in regular session with Chairman James F. Brass, Commissioners Earl T. Black and Chris Schaake, and County Clerk U. S. G. Plank present.

Claims against the County for wages, salaries, materials and labor for the County, and for the maintanence of the Poor, were presented, considered and ordered paid as per Allowance Record.

The retiring treasurer, Mr. S. S. Learned, presented his annual statement, which was completed as of October 8, 1935, to the Board for its approval. On motion of Earl T. Black and a second by Chris Schaake, and a vote of all the Commissioners, the report was accepted and approved, and the County Clerk was instructed to see that such portions of the report should be published in the official paper.

Attorney, R. B. Stevens, appeared before the Board with a petition signed by Roger Williams, R. M. Sutter, C. E. Woodward, and others to the number of nine petitioning a drainage district known as Bull Creek Drainage District including Section 33, Township 13, Range 19 in Douglas County, Kansas. The petition was presented in the form of a resolution which resolution by motion properly seconded and a unanimous vote of the Commissioners was adopted and the County Clerk was instructed to see that the proper notice of hearing was published in the official paper.

Now appears A. M. Gardner, Treasurer of Douglas County, Kansas, through auditor, Mrs. Mildred Le Suer, and asked that the following resolution be adopted:

RESOLUTION

WHEREAS a financial emergency has been created because of floods during the early part of the summer resulting in over expenditures in the County Bridge Fund, and
