The Board of County Commissioners met in regular adjourned session with James F. Brass, Chairman, Earl T. Black and Chris Schaake, Commissioners, and U. S. G. Plank, County Clerk all present.

Bills for wages, materials, and labor for the County and for the relief of the destitute were presented, scrutinized, and ordered paid as per Allowance Record.

The minutes of all regular meetings and special meetings for the month of October, including proceedings in the organization of the South Side Kaw Drainage District were read and approved as read.

The application of a Mr. Wiley Jones for admission to the County Home was presented to the Board. A motion properly seconded and unanimously voted authorized the County Poor Commissioner and Case Supervisor to complete arrangements for his admission to the home.

The Board of County Commissioners viewed the road as per petition and publication of Leonard Nuffer and others at 2 o'clock P. M. at the point of beginning of road described in his petition. Said petition being on file in the County Clerk's office.

Miss Evelyn Cruzan, County Supervisor, Mrs. Carroll D. Clark of the Community Service Committee, appeared before the Board with a comprehensive report of the activities of canning organization for the season of 1935. A brief report follows:

This was a joint service between the County and the Community Service Committee. Mrs. Carroll D. Clark on behalf of her committee made arrangements for a kitchen which kitchen was in the basement of the Christian Church of North Lawrence, purchased equipment for canning etc., etc. The county, through Miss Evelyn Cruzan, purchased the cans. The kitchen ran from July 15 to October 19. Forty-two families used the kitchen. Twenty-five families of this number were relief families. A total of 3571 quarts of foods were canned, including vegetables, fruits, and soups. It is estimated that the amount of canned goods going into the homes of relief families totaled in value \$605.00. All costs in connection with the canning of the above was \$355.00.

No further business appearing, the Board adjourned to meet at 9:30 o'clock on the morning of November 9.
