Eeker, Poor Commissioner, placed his formal resignation as Douglas County Poor Commissions before the Board, which resignation was accepted. The usual form, KENG form No. 69A was also filed and favorably acted upon. The Board also had a similar form to fore them removing Miss Abbie B. Langmaid from the office of Assistant to the County Poor Commissioner with the title "County Case Supervisor" for the reason "her term of service agreed upon, having ended and shortage of funds does not allow for further continuation". The usual form of KERC form No. 69 in completed form was presented to the Board appointing Miss Cecilia Robinson as acting County Poor Commissioner and Case Supervisor for a temporary period. All these forms were properly passed upon by the Board and the forms ordered filed.

The Board met in regular adjourned session with Commissioners Chris Schaake, and Earl T. Black and Chairman James F. Brass, County Clerk U. S. G. Plank all present.

The remainder of the bills for the month of November for wages and materials for the County and bills for the relief of the Poor and destitute were presented, scrutinized, and ordered paid as per Allowance Record.

Roger Williams, R. N. Sutters, with Attorney R. B. Stevens, met in the Commissioner's room to meet with any objectors to the formation of the Bull Creek Drainage District. No objectors presented themselves and the Board authorized proceedings for the completion of the organization of the said Bull Creek Drainage Board and instructed the County Clerk to published notice of an election to be held for the purpose of naming three directors to act as a Board of Control. Said election to be held at the home of Roger Williams between the hours of 8 o'clock A. M. and 6 o'clock P. M. on the 25th day of November, 1935.

Mrs. J. A. Kell of Lawrence, Kansas, presented an application for admittance to the hospital to Norton, Kansas for T. B. treatment which application was properly completed and presented to the Board for signature of the Chairman. It was moved and properly seconded that the County Commissioners recommend Mrs. Kell for admittance to the hospital with the understanding with Kr. J. A. Kell that the County should bill him for all expenses in connection with her transportation and treatment which bill or bills Kr. Kell agreed to pay.

With the proper motion and a second and unanimous wote of the Board, Mr. Trueblood was authorized to purchase an "cil refiner" from Mr. Minor of Topeka, Kansas, at a purchase price of \$162.50 with a 2% discount for cash.

It might be noted here that the County Commissioners received a telegram from John Stutz of Topeka, Kansas, informing the Board that the nomination of Glenn Curtis James for Poor Commissioner and Case Supervisor could not be approved by the State Committee.
