The Board of County Commissioners met in regular adjourned session with James F. Brass, Chairman, Earl T. Black and Chris Schaake, Commissioners, and U. S. G. Plank, County Clerk, present.

More bills were presented, scrutinized and ordered paid as per allowance record.

City Prisoners

The question of the County Sheriff incarcerating and feeding City prisoners was before the Board. The point in question was whether the City should pay for the boarding of its prisoners. (See Gen. Statutes Revised 1923 Sec. 19, Para. 1920) After discussion, the County Clerk was instructed to present bills to the City for the boarding of prisoners for the months of October and November, after the Sheriff had submitted a list of City prisoners for the above named months.

Health Physcian Dr. H. P. Jones, talked with the Board concerning the condition of health among the relief workers and those directly on the County.

The Douglas County Medical Society headed by Dr. W. O. Nelson, appeared before the Board to discuss with the Board the feasibility of having all relief families pay a dollar a month to the Society with the understanding that the County would pay a dollar per month for families on direct relief to said association, and that the members of the association care for the patients and pro rate the fees collected. No specific action on this suggestion was taken by the Board.

Ray Dolan through the County Attorney, R. B. Stevens, petitioned the Board for the remittance of \$100.00 fine because of a liquor charge on the condition that the District Judge parole the prisoner from his jail sentence, and on the further condition that all cost in connection with his arrest and conviction be paid.

Earl T. Black moved and Chris Schaake seconded that the above petition be allowed, and by unanimous vote of the Commissioners, it was so ordered.

The regular meetings for the month of November, namely, November 4-6-9-13 and special meetings held under the dates of November 12-19-22 were read. The Commissioners ordered several corrections in the minutes which were read, and as corrected, the minutes were approved.
