At a special meeting called by Chairman James F. Brass of the Board of County Commissioners, said meeting to convene at 1 P. M., all the Commissioners and the County Clerk were present.

The purpose of the meeting was to meet with the new district KERC, auditor Mr. Sever relative to the appointment of the hief Clerk and also to meet Miss Swingle, District Supervisor of Case Supervisor of the KERC, relative to the work in connection with the Case Department in Douglas County. Mr. Sever reviewed the past work of the Certifying officers and outlined to the Board the work expected of the Chief Clerk. In this connection he informed the Board that the Board's appointment of Leon G. Abele as Chief Clerk would be approved as soon as his nomination papers reached the office in Topeka.

Miss Swingle reviewed quite minutely the work of the Case Department and brought out some information quite interesting to the Board.

The application of Miss Geordia Harrison of Baldwin for admittance to the hospital for Tubercular people at Norton was presented to the Board in due form and after careful consideration, it was moved and seconded and voted, all the Commissioners voting to recommend her admission to the hospital at the expense of the County, and the County Clerk was instructed to forward her application at once.

No further business appearing, the Board adjourned.

The Board of County Commissioners met in regular session with the Ghairman, all the Commissioners and the County Clerk present.

Bills for materials, salaries, and for the maintenance of the Poor were presented, scrutinized and ordered paid as per allowance record.

E. E. Trueblood, County Engineer appeared before the Board with the information that because of adverse conditions touching the rebuilding of the Kaw River Bridge at Eudora, \$500.00 would be needed to complete the work on the bridge as it should be done. After some discussion the following resolution was prepared by the County Attorney and in regular form was adouted by the Board.

RESOLUTION OF THE BOARD OF COMMISSIONERS OF DOUGLAS COUNTY, KANSAS EFFECTING NEW IMPROVEMENTS ON THE EUDORA BRIDGE PROJECTS.

WHEREAS, since the execution of contracts for the improvement of the Budora Bridge as provided in Chapter 253 Session Laws of 1935, certain damage has been done at the North end of said bridge and lands surrounding said bridge, which is in need of repair and additional improvement, and

WHEREAS, it is apparent that the limit allowed by said Chapter 253 for the expenditure of money under contract for the improvement of said bridge will be exceeded, and

WHEREAS, this work is classified as General Maintenance Expense duly assessed for usual bridge maintenance and is not a part of the reconstruction of said bridge, and

WHEREAS, it is by this Resolution understood that Leavenworth County will contribute one-half of the cost, thereof, which is estimated at \$500.00.

NOW THEREFORE BE IT RESOLVED by the Board of Commissioners of Douglas County, Kansas, in regular meeting assembled this 6th day of January, 1936, that when and if, the Board of Commissioners of Leavenworth County, Kansas, shall authorize the expenditure of \$250.00 for said maintenance expense, that thereupon, this County will expend a like sum of \$250.00 out of the Regular Bridge Fund of this County, and the same is hereby authorized to be expended for said maintenance expense.
