Representatives from the Poor Commissioner's office and from the office of the KERC in Topeka were present and discussed the personnel for the relief office as to be continued for a short period from the present date. After discussion, it was moved and seconded and properly voted that for the present the office should continue with 3 stenographers, one file clerk and four case-visitors.

By resolution which was properly adopted by the Board--which resolution was the ordinary motion and a second--it was voted that Mildred D. Watson be named as a County Representative of the KERC and the KHRC--what ever this may mean.

Bids from the oil companies doing business in the County were presented by the County Engineer E. E. Trueblood and the same were opened in the presence of the Board. The following companies submitted bids:
