The Board of County Commissioners met in regular adjourned session with all the Commissioners and the County Clerk present.

The final number of bills for materials for the county, for wages and salaries and bills for the maintenance of the poor were presented, examined and ordered paid as per Allowance Record.

County Engineer, E. E. Trueblood, brought to the attention of the Board, the information that The Firman L. Carswell Manufacturing Company of Kansas City, Mo., to whom an award had been made for "billet bars" at the May 6 meeting, were unable to fill the contract, owing to the fact that the firm from whom The Firman L. Carswell Manufacturing Company were purchasing the materials, had refused to sell because of the low bid. In view of the fact because the Engineer needed these "billet bars" at once, the bids were reconsidered and The Carter-Waters Corp., Kansas City, Mo., were awarded the contract as per their bid opened on May 6, 1936. This award was made by the proper motion, seconded and the putting of the motion to the Board. All the Commissioners voting "aye".

County Engineer, E. E. Trueblood, told the Board he needed a car-load of vitrified pipes. Moved by Chris Schaaake that the engineer be authorized to purchase a car-load of pipe. Earl T. Black seconded the motion--the Chairman put the motion--and it became a vote, all the Commissioners voting "aye".

*Says Good-Bye*

Acting under Section 7 of House Bill No. 425, 1933 Session Laws, relative to the number of dependent persons for each Case-Aide, the Commissioners asked the Poor Commissioner-Case Supervisor, Mildred D. Watson, to dispense with the services of one Case-Aide at the expiration of 30 days from this date. The Board suggested that Miss Guida Burgan's services be dispensed with after 30 days, until such time when the case load makes it necessary for the reemployment of a Case-Aide at which time, if she again applies, her application will be given due consideration. The above was put in the form of a motion by Earl T. Black with a second from Chris Schaaake. The motion being put by the Chairman, it was so ordered, all the Commissioners voting "aye".

The County Engineer E. E. Trueblood presented the findings of the Board of County Commissioners which had appointed itself as a Board of Viewers on certain roads. The findings of the Board follows:

WE, THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, KANSAS. Acting under the Laws of 1923, Chapter 68 Article 114, which reads as follows: "PROCEEDINGS FOR CHANGES IN ROADS. When it is found necessary to layout, relocate, alter, widen or vacate a road or highway for the purpose of eliminating sharp turns or other dangerous places, or for the proper construction of a highway, or for the extension of a bridge or culvert, the board of county commissioners shall by order of said board layout, relocate, alter, or widen a public road and may vacate an existing road. All land required for the laying out, widening or altering of a road shall be acquired by the board of county commissioners by purchase or by donation."
