Description of the road is as follows:

A strip of land sixty feet wide by thirteen hundred fifty-three and three-tenths (1353.3) feet long more definitely described. Begin-ning at a point in the present old road 1,766 feet South of  $\frac{1}{2}$  Cor. on N line of Sec 3, T 13 S, R 18 E, there S 210.7 feet to P.C. of 20 degree curve to right, thence along said curve 393.6 feet to p.T., thence S 78° 40' W--224 feet to P. C. of 15 degree curve to left, thence along said curve 525.2 feet to P. T. which point is in center line of present old road. Strip contains 1.86 acres more or less and also vacates old road between points of beginning and ending of the above described relocation.

WE, THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, KANSAS,

Acting as Viewers of a road petitioned for by Effic Kampschroeder and others of Clinton Township, met, as heretofore dtermined and ordered by the Board, at the beginning point of the noad as petitioned for to be established on the 6th day of May, 1936 and proceeded to view the route of said road as prayed for in the petition, or as nearly so as we consider a good road can be made at a reasonable expense, taking into consideration the utility, convenience, inconvenience, and expense which will result to individuals as well as to the public if said road or any part thereof be established for public use. for public use.

Further action and hearing on the petition was postponed to the 9th day of May, 1936 at which date interested parties were notified to appear.

The Board of County Commissioners in regular session this 9th day of May, 1936, held a conference with the interested parties, and all except C. S. Barker agreed to the Commissioners proposition: Barker being one of only two Beneficiaries in this road, refused to contribute anything toward the road. Consequently, the Commissioners instructed the County Engineer to prepare claims covering their proposal, and set Wednesday May 13, 1936 for further action.

The route of said road was surveyed under our direction by E. E. Trueblood, County Surveyor assisted by C. E. Redmond and A. L. Cox, chainmen and George Moorman, marker. The report of survey, plat and field notes are hereto attached and are made part of this report and record of final action.

C. S. Barker and wife were awarded claims as follows:

For the land described as beginning at a point 990 feet North and 20 feet East/of the SW Cor. of NW# Sec. 18, T 13 S, R 18 E, thence North parallel to West line of said & Sec. 1,650 feet to a point 20 feet East of the NW Cor. of said Sec 18--continue North on same line 40 feet, thence East 20 feet, thence South 1,690 feet, thence West 20 feet to point of begin-ning--containing 775/1000 acre, more or less. This road extends 40 feet North of the NW Cor. of Sec 18, T 13 S, R 18 E.

For .775 acres of land at the unit price of \$60.00 per acre were awarded \$46.50.

This was, also, the owners' claim, with this addition:

The 105 rods of fence along the East side and North end of this 40-foot right of way will be provided by Clinton Township, and

Beginning at a point 990 feet North of the SW Gor. of NW1, Sec. 18, T 13 S, R 18 E, thence North on line 1,650 feet to the NW Cor. of said Sec. 18--continue North on same line 40 feet, thence East 20 feet, thence South 1690 feet, thence West 20 feet to point of beginning, containing 775/1000 acre, more or less. The above strip of land is hereby donated and dedicated to public road, while used for that purpose.
