*Joint Meeting
Jetties*

The minutes of the meeting of August 26th, held in the Douglas County Commissioner's rooms were read by the Douglas County Clerk. Moved by Lon Rush, of Leavenworth County, and seconded by Chris Schaake, of Douglas County, that the minutes be approved and adopted as read. The motion being put by Chairman James F. Brass was voted on. All the Commissioners voting Aye, May none.

The engineers from the two counties explained to the boards that the building of jetties and bridge plans combined could not be completed in time for the letting of bids and getting work started by October 1, and informed the board through the advice of the Council that to present the specifications and plans for the building of jetties would be in line and legally within the requirements of the Federal Emergency Relief Administration of Public Works.

Whereupon, the plans and specifications as approved by the engineers of the two counties for the construction of the jetties in connection of the Eudora Bridge Project were minutely explained and fully discussed.

The following resolution was presented:

JOINT RESOLUTION OF THE LEAVENWORTH AND DOUGLAS COUNTY COMMISSIONERS

WHEREAS: The contract and specification for timber built jetties in connection with the Eudora Bridge have been submitted to the joint boards of Douglas and Leavenworth Counties and have been approved by the State Director of the Federal Emergency Administration of Public Works and also approved by the County Engineers of Leavenworth County and Douglas County,

BE IT THEREFORE RESOLVED: That said contract and specifications be approved and they are adopted.

BE IT THEREFORE RESOLVED: That the County Clerks of Leavenworth and Douglas County be instructed to advertise for bids for said construction and that said advertisement be in conformity with the law.
