Black and a vote of all the commissioners it was authorized and ordered that he should have a stenographer one week at a wage of \$12.50 per week.

No further business appearing the board adjourned to meet September 9 in an adjourned meeting at the hour of 9:50 A. M.

It might be noted here that a couple of employees from the Engineer's Office, who had a pretty strong bill for overtime, were called before the Board and asked for an explanation. After careful and minute consideration of these bills, with the parties interested therein, the bills were allowed with the understanding that no precedent is established. In fact it is agreed by the parties interested therein that there would be no overtime charges against the county in the future. With this understanding the bills were authorized and paid as presented.

Mr. Carson and a Mr. Henry of the west part of the county, together with Ogden Jones of the State Water Conservation Department at Topeka, appeared before the Board relative to a pond to be built on the farms of the said Carson and Menry. The plans for the construction of a pond was described and the Board signified its intention of lending as much assistance in the completion of the pond as is permissible within the scope of the county's activities.

The Board of County Commissioners and the County Engineer made a trip to the recently completed county bridge known as the Cooper bridge for the purpose of inspection. They pronounced the completed work very good.

The County Poor Commissioner--Case Supervisor, Mrs. Watson, met with the Board for a general discussion of the work in hand in her department. No formal action for record was taken on any of the phases discussed.

County Engineer, E. E. Trueblood, presented two road petitions to the Board.
