

COMMISSIONER'S RECORD M

September 16, 1936

The Board of County Commissioners, James F. Brass, Chairman, Earl T. Black and Chris Schaake, Commissioners, and U. S. G. Plank, County Clerk, met in regular adjourned session at 9:30 A. M.

The final bills of the County and of the Poor Commissioner's office for the month of August were presented, scrutinized, and ordered paid as per allowance record.

The Board's attention was called to the Minimum Wage Scale as set out by the WPA in connection with the Crescent Road Project. The question was disposed of in the following resolution:

A RESOLUTION ADOPTING A SCHEDULE OF MINIMUM WAGE RATES FOR TRADES AND OCCUPATIONS WHICH MAY BE EMPLOYED IN THE CONSTRUCTION OF DOCKET NO. KANS. 1150-R DOUGLAS COUNTY KANSAS HIGHWAY IMPROVEMENTS.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, KANSAS.

Section 1. It is hereby found and determined that the schedule of wages designated "Schedule D" as set forth in S. D.

(A, B, C, D, or E)

Kans. Bulletin No. 11, is in accordance with local wage conditions in this community to apply to the trades and occupations which may be employed as indicated.

Section 2. The said schedule is hereby approved and adopted as the minimum rates to apply in the construction of Docket No. Kans. 1150-R Douglas County, Kansas Highway Improvements.

Chris Schaake moved the adoption of the above resolution. Earl T. Black seconded the motion to adopt. James F. Brass put the motion and it was voted, all the Commissioners voting "aye".

Two auditing firms presented bids for the 1936 audit of the county's books. W. C. Hall and Company of 905 Missouri, presented a bid containing the following propositions:

- a. County Treasurer, for a one year period ending in October, 1936, and the following offices for a one year period ending December 31, 1936:
County Clerk; Clerk of District Court; Sheriff; Probate Judge; County Attorney; Register of Deeds; County Engineer; Justice of Peace (2); and County Superintendent of Public Instructions.
- b. The compensation for this work shall be fourteen dollars (\$14.00) per day of eight hours, for each Licenses Accountant and Twelve dollars (\$12.00) per day, for Senior Accountants, while engaged on the audit, which shall include the Auditor's and Typist time, audit report material and all other necessary expenses incident to the preparation and completion of the audit report.

It is understood and agreed that the total maximum cost of this audit, to Douglas County, shall not exceed the sum of Six Hundred Dollars.

J. E. Caton Company of Topeka, Kansas, bid as follows:

We propose to audit the County Treasurer, County Commissioners and General Records, County Clerk, Register of Deeds, Clerk of the District Court, Probate Judge, Sheriff, County Attorney, County Superintendent, County Engineer, and two Justices of the Peace (Lawrence, City, Township) for the period January 1, 1936 to December 31, 1936, or to January 11, 1937, in case where there is a change of officers, for the consideration of \$400.00 payable monthly as the work progresses on estimates approved by the County Commissioners.

The two bids were duly considered and it was moved by Chris Schaake that the bid of the J. E. Caton Company be accepted. Earl T. Black seconded the motion; Chairman James F. Brass put the motion. Voting for the Motion: James F. Brass, Chairman; Earl T. Black and Chris Schaake, Commissioners. Against the motion: None.
