and adjacent Streets or thorofares, covered by Public Works Administration Project Docket Kansas 1150-R. <u>Preliminary:</u> I will make the necessary preliminary Surveys incident to, and necessary for, the proper design of the pavement and, drainage structures. <u>Specifications:</u> Specifications for the work shall take up in detail all material and workmanship involved in the proper construction of the work, and shall conform to the best practices for pavement construction. <u>Plans:</u> Plans will show the work in sufficient detail to provide a clear understanding of the work, and to insure its proper completion. Plans will be of standard size and layout.

Estimates: I will make construction estimates for the improvement, showing the number of units of each item of construction, the estimated cost of each item, and the total cost of each item for the entire improvement. During the period of construction I will prepare all monthly and final estimates as may be required by law, or as may otherwise be required.

Supervision of Construction: I will furnish such competent resident engineer, and inspectors, as shall be necessary to insure that the work is carried out in conformity with the requirements of the plans and specifications for the improvements. I will make such tests of material as shall be necessary to insure materials conforming to requirements.

Forms: I will prepare all Engineering forms required for letting the contract: "Notice to Contractors", "Proposal" "Contract" and "Bond", and such other forms as may be required by the Public Works Administration.

Terms: Terms covering the plans, specifications, and general supervision of the work are three percent of the total cost of construction, plus \$250.00 per month for supervision and inspection, and payable as follows: Two percent of the cost of construction to be paid on the first of the month following the beginning of construction work, Supervision to be paid monthly. Supervision to commence when the contractor for the project begins work, and to end when final estimate and other necessary final forms are completed and filed with the County Clerk. One percent of the cost of construction to be paid when final estimate is filed with the County Clerk and approved by the County Commissioners. Providing, however, that in no case shall the whole amount paid for Engineering and Supervison of construction under the terms of the proposal, exceed an amount equal to six and one-half ( $6\frac{1}{27}$ ) percent of the total cost of construction.

Execution of Proposal: This proposal when accepted by resolution and signed by the Board of County Commissioners of Douglas County, Kansas, shall become a binding contract between the County Commissioners of Douglas County, Kansas and B. M. Babb.
