

COMMISSIONER'S RECORD M

November 25, 1936.

(As a notation, in the event it might be needed at some future day, the County Clerk herein records the fact that on the 25th day of November, 1936, he, together with the Chairman of the Board of the Douglas County Commissioners, executed \$14,000.00 in bonds; the said bonds being the first installment of the issue necessary to meet conditions pertaining to the Eudora Bridge Project, Kansas 1294-R Contract No. 2. Said bonds were delivered to the Estes Payne and Company of Lawrence, Kansas, who paid par \$14,000.00 and accrued interest of \$17.50. The proceeds from this sale were immediately deposited with the County Treasurer as per his receipt on file in the office of the County Clerk.)

At a meeting of the Board of County Commissioners, called by its Chairman James F. Brass, the following commissioners and County Clerk were present; Namely, James F. Brass, Chairman, Earl T. Black and Chris Schaake, Commissioners and U. S. G. Plank, County Clerk.

The meeting was called for the purpose of providing equipment for wells which were dug during the late summer for the relief of farmers who were short of water. The County Engineer E. E. Trueblood was asked to communicate with the KERC at Topeka with the view of leasing equipment, if possible. Failing in this, he was authorized to secure prices from dealers in Lawrence as to prices for well tubing, pumps and other equipment necessary for the complete installation for the pumping outfit on each well.

Mrs. Mildred D. Watson, Poor Commissioner-Case Supervisor, appeared before the Board with two projects, proposed under the Works Progress Administration.

One called for a "Project for cleaning and renovating public buildings." It was proposed that the buildings of the County Farm should be thoroughly cleaned and painted. The amount of \$3,364.80 is to be advanced as federal funds with the understanding that the County or Sponsor would furnish \$300.00.

Another proposal from the same source is a "Project to be provided for home demonstration and extension workers to disseminate information in lieu of relief regarding diet, budget, planning home economics and home management." Under this proposal the PWA is to furnish \$3,749.20, with the County or Sponsor furnishing \$200.00.

These proposals were read to the Board and after due consideration, it was moved by Chris Schaake that the above Works Progress Administration proposals be accepted. This motion had a second in Earl T. Black. The motion was put by the Chairman James F. Brass and voted, all the Commissioners voting "Aye".

As a matter of record, the County Clerk called attention to the \$14,000.00 check he had in his possession, which represented the proceeds from sale of bonds for the work on the Eudora Bridge. The Board directed the County Clerk to send such check to Leavenworth by messenger, said messenger being John E. Stephens.

No further business appearing, the Board adjourned.

December 7, 1936.

The Board of County Commissioners met in regular session, with all the Commissioners and Deputy County Clerk, T. R. Gerhart present.

Deputy County Clerk, T. R. Gerhart presented the expense items of the General Election and filed reports following the distribution of charges against the various taxing units, namely, City of Lawrence and the townships of the County. This was carefully inspected and disposed of as follows:

Moved that the County Board approve the election charges as presented by the Deputy County Clerk and that the Treasurer be instructed to credit the General Fund in the sum of \$2,993.93 and charge relative amounts against the townships and the City.

This motion was put by the Chairman and voted, all the Commissioners voting "aye".
