

## RESOLUTION

WHEREAS, it is now the finding of this Board that the Poor Fund of Douglas County Kansas is insufficient to meet general maintenance expenses for the current tax year, and whereas, the rates of levy in said County are so limited as to be insufficient for the raising of funds necessary to supply the needs of said county for said poor fund.

NOW THEREFORE, be it resolved by the Board of Commissioners of Douglas County Kansas in special meeting assembled this 22th day of December, 1936 that application be made to the Tax Commission of the state of Kansas, under the authority of Section 79-1937, 1933 Supplement, for the issuance of emergency tax warrants.

The Board of County Commissioners and the County Clerk met in special session with all the Commissioners and the County Clerk present.

As per notification to the various automobile agencies of the county, all of whom were requested to present bids to the County Commissioners for the purpose of selling to the Commissioners a car for the Sheriff's office. Fourteen dealers submitted bids.

The Commissioners carefully considered all bids and finally in consultation with the Sheriff, Fred Vogler, the sale of the car was awarded to Schneider Brothers of Lawrence, Kansas. The old 1934 Ford car, now in possession of the County Sheriff was accepted by Schneider Brothers as a part of the purchase price. Purchase price \$554.25 plus the trade-in car.
