

# COMMISSIONER'S RECORD M

WE, THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, KANSAS, Acting as VIEWERS of a road petitioned for by Fred Gregory and others of Kanwaka TOWNSHIP, met, as heretofore determined and ordered by the Board, at the beginning point of the road as petitioned for to be established on the 13th day of January, 1937, and proceeded to view the route of said road as prayed for in the petition, or as nearly so as we consider a good road can be made at a reasonable expense, taking into consideration the utility, convenience, inconvenience, and expense which will result to individuals as well as to the public if said road or any part thereof be established-altered-vacated-opened- closed for public use.

Further action and hearing on the petition was postponed to the 21st day of January, 1937, at which date interested parties were notified to appear.

On the above date, the three members of the Kanwaka Township Board and Mr. Fred Gregory, principal petitioner, met with the undersigned Douglas County Board and discussed the various features of the proposed road; such as the convenience to Mr. Gregory, the utility to the general public, and the cost of necessary right of way, road construction and maintenance in the future.

In this meeting, it developed that the Township Board was opposed to opening this road as petitioned, on the ground that Mr. Gregory was not shut in, but had a good road from his place to the Federal Highway, and the proposed road as petitioned would be practically a private road.

The route of said road was not surveyed.
