Thereupon, Commissioner Earl T. Black presented and moved the adoption of the following resolution authorizing the issuance by Douglas County, Kansas, of its Public Work Relief Bonds in the sum of \$11,000.00 pursuant to the provisions of said Chapter 190.

Said motion was seconded by Commissioner James F. Brass.

Said resolution was thereupon read and considered, section by section and as a whole, and was adopted by the unanimous vote of the three Commissioners, the vote being as follows:

The resolution adopted as aforesaid is as follows:

RESOLUTION AUTHORIZING THE ISSUANCE BY DOUGLAS COUNTY, KANSAS, OF ITS PUBLIC WORK RELIEF BONDS IN THE SUM OF \$11,000.00 FOR THE PURPOSE OF PAYING THE COST OF SUPER-VISION, ENGINEERING, INSPECTION, MATERIALS, SUPPLIES AND OTHER EXPENSE OF PUBLIC WORK RELIEF, PUBLIC EMPLOYMENT, AND PUBLIC WORKS PROJECTS IN DOUGLAS COUNTY, KANSAS, NOT PAID FOR BY THE STATE OR FEDERAL GOVERNMENT.

WHEREAS, the Board of County Commissioners of Douglas County, Kansas, does hereby find and declare that the funds of the Board of County Commissioners of Douglas County, Kansas, are insufficient to bear the cost of the supervision, engineering, inspection, materials, supplies and other expense of public work relief, public employment, and public works projects in Douglas County, Kansas, not paid for by the State or Federal Governments on public work relief, public employment, or public works projects approved as work relief, public employment, or public works projects by the State or Federal Government authorized under the acts of Congress of the United States or of the State of Kansas, and

WHEREAS, said Board of County Commissioners of Douglas County, Kansas, does hereby find and declare that for the purpose of providing funds to bear the cost of supervision, engineering, inspection, materials, supplies and other expense of public work relief, public employment and public works projects in Douglas County, Kansas, not paid for by the State or Federal Government on projects approved as work relief, public employment, or public works projects by the State of Federal Government, it is necessary that said County authorize the issuance of the Public Work Relief Bonds of said County in the principal sum of \$11,000, pursuant to the provisions of Chapter 190, enacted by the legislature of the State of Kansas, in 1935, approved by the Governor of said State on March 2, 1935, and that the bonds to be authorized as aforesaid be issued, sold and delivered immediately, and

WHEREAS, said Douglas County, Kansas, has not heretofore issued bonds under the provisions of said Chapter 190, except:

We quote from Commissioner's Record N, page 293, under date, November 12, 1936--"For the legally issued Bridge Bonds of Douglas County, in the par value of \$14,000.00 delivered to us at our office in Topeka, Kansas, dated Nov. 1, 1936, to mature \$500.00 May 1, '38 to '46; \$1000.00 November 1, '38 to '46 and \$500.00 November 1, 1936, to be in denomination of \$500.00 hearing interest from November 1, 1936, at the rate of 1 7/8% per annum payable semi-annually both principal and interest payable at Fiscal Agency."

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, KANSAS, IN MEETING DULY ASSEMBLED:

Section 1. That for the purpose of providing funds to pay the cost of supervision, engineering, inspection, materials, supplies and other expense of public work relief, public employment, and public works projects in Douglas County, Kansas, not paid for by the State or Federal Government on public work relief, public employment and public work projects, approved as such projects by the State or Federal Government authorized under the acts of Congress of the United States or of the State of Kansas, there are hereby authorized to be issued Public Work Relief of Douglas County, Kansas, in the total principal sum of \$11,000.00. Said sories of bonds shall consist of eleven bonds, numbered from One to Elven inclusive, shall be in the denomination of \$1000.00 each. All of said bonds shall be dated February 1, 1937, and said bonds shall become due
