Gentlemen:

Reference is made to Art. 4 (EXTENSION) page 5, of the contract for this project.

Due to the unfavorable weather conditions existing during the time this project has been active, it has been impossible to make progress on the construction of this work.

After thorough consideration of these conditions as above outlined and as shown by the Project diary, we find that the contractor is entitled to an extension of time on the above project in the amount of sixty-seven (67) calendar days, beginning with the last day of February inclusive.

We therefore request that the contractor M. N. Penny, be given an extension of time of 67 days for the completion of Project PWA 1150 R.S. Kan.
