

## COMMISSIONER'S RECORD M

Immediately after assembling, the Board and the County Clerk, accompanied by Mildred D. Watson, Poor Commissioner, E. E. Trueblood, Engineer and County Health Officer H. Penfield Jones, repaired to the County Farm on a trip of inspection of the renovating job now in progress under a WPA project. The question of fixing up two rooms as hospital wards was discussed, also. The possibility of erecting two fire escapes, one at the north end of the building and the other at the south end of the building was looked into and discussed. Several suggestions were made but no formal action was taken on contemplated improvements.

The Board of County Commissioners met in the first regular meeting for the month of April, in the chambers of the said Commissioners with Chairman Chris Schaake, Commissioners Earl T. Black and James F. Brass, and Deputy County Clerk T. R. Gerhart present.

Claims against the county for wages and materials and claims from the Relief Department for the relief of the Poor were presented to the Board, and after being minutely inspected were ordered paid as per Allowance Record.

Attorney C. C. Stewart, representing the petitioners for the improvements in the paving, curbing, grading and drainage of Crescent Road, appeared before the Board in the interest of said petitioners. He submitted to the Board for its approval, the following resolution:

#### R E S O L U T I O N

WHEREAS, heretofore and pursuant to a proper petition filed, a resolution was adopted by the Board of County Commissioners of the County of Douglas, State of Kansas, authorizing the improvement of Crescent Road, the same lying entirely outside the limits of any incorporated city, in Douglas County, Kansas, and described as:

Commencing at a point 662 feet north of the Southeast corner of the Southwest Quarter of Section 36, Township 12, Range 19, in Douglas County, Kansas, and extends in a generally westerly direction to a point 838 feet East and 475.4 feet North of the Southwest corner of said Section 36, thence running South to the South line of said Section 36, all being in Douglas County, Kansas.

by the construction of a re-inforced concrete paving 25 feet wide, including integral curb and guttering, together with necessary grading and drainage thereof, under the provisions of Section 68-728 of the 1933 Supplement to the Revised Statutes of Kansas for 1923, being Section 68-728 of the General Statutes of Kansas for 1935, said resolution having been published according to law and no protest against the performance of such work having been filed, said improvement was authorized and a contract was let therefor, and

WHEREAS, the property abutting on the East 1146 feet of the above described road is platted and divided into lots and blocks, and a petition has been filed signed by the owners of more than fifty per cent of the platted land abutting on said East 1146 feet of said road, asking that such part of said road be paved to a width of 30 feet, including integral curb, in place of the 25-foot width originally petitioned for and acted upon in the resolution mentioned, provided that the Federal Emergency Administration of Public Works approve the same,

BE IT RESOLVED that the Board of County Commissioners of the County of Douglas, State of Kansas, deem it necessary to pave the East 1146 feet of the above described road to a width of 30 feet, including integral curb, in place of the 25 feet heretofore provided for, and

BE IT FURTHER RESOLVED that said East 1146 feet of the above described road be so paved and that the cost thereof be paid in the manner provided for in Section 68-728 of the General Statutes of Kansas for 1935, and provided that the Federal Emergency Administration of Public Works approve the same, and

BE IT FURTHER RESOLVED that this resolution be published for three consecutive weeks in the official paper of Douglas County, Kansas, according to law.
