

A petition signed by I. C. Bushong and eight others was presented to the Board by Attorney Stewart. The petition follows:

P E T I T I O N

TO THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS,
STATE OF KANSAS

WHEREAS, Crescent Road is a road

Commencing at a point 662 feet North of the Southeast corner of the Southwest Quarter of Section 36, Township 12, Range 19, in Douglas County, Kansas, and extends in a generally westerly direction to a point 838 feet East and 475.4 feet North of the Southwest corner of said Section 36, thence running South to the South line of said Section 36, all being in Douglas County, Kansas,

such road lying outside the limits of any incorporated city, and Douglas County, Kansas having a population of more than 20,000, and

WHEREAS, heretofore a petition was filed with the said Board of County Commissioners of the County of Douglas, State of Kansas, petitioning for the paving, grading and draining of said Crescent Road, as above described, such paving to be of a width of 25 feet and of re-enforced concrete, including integral curb, and to charge the cost thereof on the land abutting on said road, all according to the provisions of Section 68-728 of the General Statutes of Kansas for 1935, formerly Section 68-728 of the 1933 Supplement to the Revised Statutes of Kansas for 1923, provided that none of said improvements be made unless the Federal Emergency Administration of Public Works make a grant of 45 per cent of the cost of said project, and

WHEREAS, the Federal Emergency Administration of Public Works has approved a grant of 45 per cent of the total cost of such project up to a maximum of \$14,463.00, and

WHEREAS, said Board of Commissioners, by resolution, duly made proper findings and authorized said work to be done, and

WHEREAS, it is believed by the undersigned that it would be much better for the community at large, including Douglas County and the City of Lawrence and the people living in said community and to use said road, as well as to the property abutting thereon, that the East 1146 feet of said road be not 25 feet but 30 feet wide of re-enforced concrete paving, including integral curb, together with grading and drainage.

We, the undersigned owners of the land platted and unplatted fronting on said road from its point of beginning, as above mentioned, to a point 1146 feet West therefrom, being at the West line of University Heights, Part 2, an Addition adjacent to the City of Lawrence, in Douglas County, Kansas, do now petition to the Board of Commissioners of Douglas County, Kansas, to pave with a 30-foot re-enforced paving, including integral curb, also grade and drain, said part of Crescent Road as herein described, and charge the full cost thereof to the land abutting on that part of said Road, all according to the provisions of Section 68-728 of the 1933 Supplement to the Revised Statutes of Kansas for 1923, provided, however, that Federal Emergency Administration of Public Works approve the same.
