Motion was put by the Chairman, all Com. voting "Aye." She also presented a requisition requesting the grant, from KERC, of raw cotton to be processed into cotton bats for comforters for the sewing project under WPA. (Requisition on file in County Clerk's office.) The following resolution was adopted by the Board: RESOLUTION WHEREAS, the K.E.R.C. have on hand raw cotton that may be processed into cotton batts, and WHEREAS, the County of Douglas is in need of cotton batts for the making of comforters in their W.P.A. sewing room, and WHEREAS, the County of Douglas is sponsoring a sewing project under W.P.A. and same is available for making comfortors. Azu Cotton Kipe. NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS.OF DOUGLAS COUNTY, KANSAS, in regular session assembled: That we requisition enough cotton to be processed into 200  $3\frac{1}{2}$  lbs. batts. Brass that the Board authorize Mildred LeSuer, County Auditor, and Charles A. Springer, County Attorney, to make proper application to the State Tax Commission for permission to issue some §20,000.00 in bonds for relief purposes. The resolution and application follow: RESOLUTION FOR THE ISSUANCE OF BONDS FOR THE RELIEF OF THE POOR AS PROVIDED IN SECTION HOUSE BILL 333 1 vosoo OVIDED IN SECTION HOUSE BILL WHEREAS, it appears to the Board that additional revenue will be needed for relief of the poor and destitute of the County of Douglas, State of Kansas, and that the funds on hands for said purpose will be inadequate for the care of the poor and destitute. WHEREAS, the County of Douglas had for the year preceding an assessed valuation of \$35,897,980 and whereas under Section \_\_\_\_\_\_\_ of House Bill  $\mathcal{III}$  section Laws of 1937, it is provided that the County may issue bonds for the relief of the poor not exceeding one-third of one per cent of assessed valuation. NOW THEREFORE, be it resolved by the Board of County Commissioners of Douglas County in an adjourned regular session this 14th day of April, 1937, that pursuant to House Bill 533 the County of Douglas issue bonds in the sum not to exceed \$20,000.00 the same to mature in equal amounts each year for a period not exceeding ten years, the said County to annually make a levy covering the interest accruing and the bonds maturing during the next budget year, and that this proposal to issue bonds be submitted to the State Tax Commission of the State of Kansas for their approval. their approval.
