The Chairman of the Board of County Commissioners of Douglas County, Kansas, and the Clerk of said County are hereby uthorised and directed to prepare and execute the bonds hereinbefore escribed, and to procure their proper registration in the office of the county Clerk and in the office of the Auditor of the State of Kansas, and, when so emecuted and registered and rejected by the State School und Commission, to deliver the same to the purchaser thereof upon syment of the purchase price.
