The following resolution was passed authorizing the County Clerk to issue John Dillon a beer license for consumption on the premises:

R E S O L U T I O N

WHEREAS, on the 25th day of May, the same being the adjourned meeting of the Board of County Commissioners, the application of John Dillon for beer license, came on for consideration of said Board, and

WHEREAS, the Board finds that the said John Dillon is in all ways qualified under the law to sell cereal malt beverages for consumption on premises, and

WHEREAS, the Board further finds that a due and legal notice has been given to the Wakarusa Township Board, and that the ten days have expired from the giving of said notice and that no objection has been filed by said Board.

NOW, THEREFORE, BE IT RESOLVED that the applicant John Dillon be granted a license to sell cereal malt beverages for consumption on premises.

BE IT FURTHER RESOLVED that T. R. Gerhart, County Clerk of Douglas County, be instructed to issue said license.

The Commissioners of Douglas County met this day for the final meeting of the 10 day session of the Board of Equalization with all the members of said Board and the County Clerk present.

R. B. Stevens, Attorney, in the interest of R. C. Miller, came before the Board in regard to a reduction of the valuation on property described as: Massachusetts Street, N² of Lot 35 and S² of Lot 35, known as the Miller Building. It is Mr. Miller's contention that the valuation as compared with adjacent properties is out of line, and he hereby requests the Board of Equalization to adjust such discrepancy. For disposition of such, see minutes of June 10.

Mr. W. F. Jordan came before the Board in reference to a new home built in 1936 by Mr. Jordan. Mr Jordan says the valuation of the house as now stands on the assessment roll is out of line with adjacent properties.

The Board with the County Clerk viewed and inspected the property of Mr. Jordan, and made disposition of such as of June 10, 1937.

Mrs. Will Hey and Miss Hey from Baldwin City, Kansas, appeared before the Board concerning the assessment of personal property of the Hey Machine Company in Palmyra Township. They stated that the valuation as placed by the deputy assessor is excessive, and wished the Board to adjust the discrepancy. Final action taken on a later date.

The Board adjourned as a Board of Equalization and reconvened as a Board of County Commissioners.

Clarence Bliesner of the Lawrence Typewriter Exchange came before the Board in regard to a new adding machine that the County is anticipating on buying. He presented literature and explained to the Board the merits of the machine. He submitted his bid to T. R. Gerhart, County Clerk, to be considered at a future date.

Mr. Frank Holliday and Mr. David Passon were in to discuss the house at 638 New Hampshire Street in regard to the tenants now in the place and their vacating by the 4th of June, in order that the County may take over the house at that time.
