The Board of County Commissioners met in regular adjourned session this 16th day of June, 1937, with the following named persons present: Chairman Chris Schaake and Commissioner Earl T. Black and James F. Brass and County Clerk T. R. Gerhart.

The Kanwaka Township Board appeared before the Board asking authorization for a work project under the County Blanket Project.

It was explained to the Township Board by Engineer E. E. Trueblood that as yet our application for a Blanket Project for the coming fiscal year has not been approved by the government, and until such application is approved, the Board is unable to grant the request of the township Board. When such approval is received from the government, the Township will be considered.

Mr. Otto Hack and County Engineer Trueblood discussed with the Board the matter of men from the Engineer's office doing the surveying for the government job of aerial pictures which are to be taken in the near future.

It was definitely understood at this time that three experienced men from the Engineer's Department would do the surveying of the county, the said men to be paid \$4.00 per day by the government.

Mr. W. P. Olmsted and County Engineer Trueblood conferred with the Board regarding the repairing of the Courthouse roof. After considerable discussion, it was moved by Earl T. Black that the contract be awarded to Olmsted Brothers for the repairing of the Courthouse roof with a slate roof, using all old slate that is possible, and completing the rest with new slate. James F. Brass seconded the motion and on vote put by Chairman Chris Schaake, all Commissioners voted in favor of the motion.

The contract follows:

CONTRACT

This AGREEMENT entered into this 16th day of June, 1937, by and between Douglas County, Kansas, by the Board of County Commissioners, Chris Schaake, Chairman, Earl T. Black and James F. Brass, members of said Board of Commissioners, party of the first part; and Olmsted Brothers, Building Contractors, residing in and doing business in the said Douglas County, Kansas, parties of the second part.

WITNESSETH: that for and in consideration of the sum of Twenty-five dollars (\$25.00), paid to them by the party of the first part when the work herein specified has been completed, the parties of the second part agree to supervise, under the direction of the County Engineer, the repair work on the Douglas County Courthouse roof, located along the south edge and extending entirely across the width of the building. This work will necessitate the removal of the present slate roof, from the eave gutter up as far as the rafters, plates, sheeting or any other portion of the wooden structure has been damaged by decay; remove all decayed or damaged wooden portion, and replace same with sound material of the proper size; also replace the slate roof using old slate shingles that are found
