That the Board of County Commissioners of the County of Douglas, State of Kansas, a municipal corporation, for value received, does hereby acknowledge itself to be indebted to, and promises to pay to the bearer hereof, the sum of \$11,225.94 in lawful money of the United States of America, on the 16th day of June, 1959, or the due date of the first installment of bonds to be issued for the payment of the improvements hereinafter mentioned, as may be scener in point of time, together with interest thereon at the rate of three per cent per annum, payable semi-annually on the 16th day of June and the 16th day of December of each year after the date hereof, until the principal sum hereof shall be fully paid, both principal and interest of this note being payable **a**t the office of the Treasurer of Douglas County, Kansas, in theCity of Lawrence, Douglas County, Kansas, and the Board of County Commissioners of the County of Douglas, State of Kansas, is held and firmly bound by these presents, and the full faith, credit, and resources of said Board of County Commissioners are hereby pledged for the prompt payment of said principal and interest at maturity.

This note is issued for the purpose of evidencing indebtedness incurred and heretofore duly authorized by the Board of County Commissioners of the County of Douglas, State of Kansas, for the making of certain improvements, to-wit, the paving, curbing, grading and drainage of Strong Avenue and Creecent Road, which improvements are to be paid for in part by the issuance of bonds, under authority of R. S. 68-728, and this note is issued under the authority of and in conformity of the provisions, restrictions, and limitations of the Constitution and Laws of th State of Kansas, and specifically authorized by R. S. 10-123, being of the Reyised Statutes of Kansas for the year 1923, and this note, together with all interest to become due thereon, is to be paid by said Board of County Commissioners of the County of Douglas, State of Kansas. the
