RESOLUTION

WHEREAS, a proposed State Lake project is now under construction in Douglas County, Kansas, and WHEREAS, it will require approximately Fifteen Thousand Dollars (\$15,000.00) to acquire the balance of the right of way for the park and to furnish the material for a dam now under construction, and WHEREAS, the park area has not been conveyed to the State to date, and WHEREAS, the County of Douglas has been authorized by law to issue bonds for the purpose of acquiring said park area and purchasing and furnishing materials for the completion of said dam and park.

NOW THEREFORE BE IT RESOLVED, that the Forestry, Fish and Game Commission of the State of Kansas, does hereby relinquish all rights and equities in the Douglas County State lake Project, otherwise known as the Lone Star State Lake Project, to the County of Douglas, in order that the County Commissioners of Douglas County may purchase and acquire the title to the land in said park and that the said County of Douglas through its Commissioners may purchase and furnish material for the completion of the dam and park new under construction, and do all the things necessary for the final completion of the project, AND BE IT FURTHER RESOLVED, that after said project is completed and the same approved by the Engineers for the Forestry, Fish and Game Commission that the County of Douglas by its Commissioners, if legally authorized, may reconvey the Park area, including all improvements and appurtenances, by deed to the State of Kansas or the Forestry Fish and Game Commission, providing however, that the title to the land within the park area be first approved by the attorney for the Forestry, Fish and Game Commission,

The above resolution was adopted by the Forestry, Fish and Game Commission at its meeting at Topeka on June 9, 1937.
