The Board of County Commissioners of Douglas County met this 7th day of July in regular adjourned meeting in the chambers of said Commissioners with all members of the Board and the County Clerk present.

County Attorney Charles A. Springer and John Brand, Attorney for H. T. and H. P. Jones, Physicians, met with the Board to discuss the matter of the payment of unpaid claims for services rendered for the county.

The question of said claims being legal, was discussed by persons present. Attorney Brand submitted the claims again for payment.

As yet, no claim on the above matter has been allowed.

In a discussion on the drought situation in Douglas County, at this time, it was deemed by the Board of County Commissioners that an emergency exists. The following resolution was passed by the Board:

R E S O L U T I O N

WHEREAS, it appears to the Board of County Commissioners that a drought now exists in this county and there is a shortage of water for stock; and it is imperative that water be supplied from the County wells, and

WHEREAS, the said Board of County Commissioners desire to open said wells to the public.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Douglas County that a drought emergency exists in Douglas County and that there is a shortage of water, and that the Douglas County wells be open for the public use.
