The Commissioners of Douglas County, Kansas, met this day in regular adjourned session with County Clerk T. R. Gerhart, present.

John E. Metsker, Superintendent of the County Farm, came before the Commissioners to discuss the matter of painting the barns at the County Farm, said barns being badly in need of paint.

The Board approved the painting of said barns and authorized Mr. Metsker to see that the work was done.

Bids on tax receipts as received by the County Treasurer were presented to the Board at this time. The bids opened and considered are as follows:

A Mr. Ice appeared before the Board relative to damage to a pond on his property when rock, being hauled during the widening of a County road adjacent to Mr. Ice's property, was dumped into said pond. He is asking the County to repair the damage as soon as possible.

The Board informed Mr. Ice that they would view the said place in the very near future.

Rev. Warde of Lecompton, came before the Board in regard to the destruction of an old dormitory at Lecompton, and what steps were required in order to purchase material--such as rocks, from the old building. Rev. Warde stated that the building is considered a hazard to the safety of children and people around that vicinity, and should rightfully be condemned.

The Board instructed Rev. Warde to see the County Attorney.

Register of Deeds, Harold A. Beck, came before the Board to discuss the matter of setting up a new system of record keeping in his office using the new Flex-Site system.

Detailed information and the cost of such a system was gone into, but no approval, as yet, was given by the Board.
