

COMMISSIONER'S RECORD M

County Clerk, Don E. Harbison, from Franklin County, appeared before the Board to discuss several matters pertaining to the new blindweed law and the Social Security Set-up.

Clifton Ramsey, Attorney for the Lone Star Lake Association, presented to the Board a resolution passed by said Association giving all rights etc. to the County if they take over the Lone Star Lake.

At a special meeting of the Board of Directors of the Lone Star State Lake Association held July 15, a quorum being present, the following resolution was unanimously adopted:

Moved by Ramsey, seconded by Boyce, that the Lone Star State Lake Association does hereby adopt the following Resolution:

"That the Association will transfer all right, title, and interest to all properties now owned, and all concession rights held in the Lone Star State Lake Project, to Douglas County, with the exception of certain lots, or lot site properties, on the southwest arm of said lake which have been platted on the D. F. Smith land, the Jaedicke land, and the Webber land. These lot sites are to be transferred direct to the purchasers who have financed this project to this point of completion. For the consideration of the Association transferring all its properties other than those above mentioned to the County, the County agrees to issue bonds to take care of such indebtedness owed by the Association as indicated by statement now in the hands of the County Commissioners. The Association agrees to transfer all land within the Park boundary, and outside the Park boundary which it now holds to Douglas County and it will refrain from selling any other property or lot sites other than above mentioned.

The Association also agrees to continue its work and cooperate fully with the County Commissioners in the same interest that it has worked with the Forestry, Fish and Game Commission in the past to see that this project is satisfactorily completed and maintained for the benefit of the general public."

Charles A. Springer, County Attorney, presented a resolution drawn up at the request of the Board for the County declaring the intention of acquiring the Lone Star Lake.

RESOLUTION DELCARING THE INTENTION OF THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, KANSAS, TO ACQUIRE TITLE TO LANDS FOR THE PURPOSE OF A PUBLIC PARK AND RECREATIONAL GROUNDS FOR IMPROVEMENT OF THE SAME AND THE ISSUANCE OF BONDS THEREFOR IN AN AMOUNT NOT TO EXCEED \$15,000.

WHEREAS, under Chapter 194 of the 1937 Session Laws of Kansas, the Board of County Commissioners of Douglas County, Kansas, are authorized to establish or complete parks and recreational grounds within said County and may purchase or acquire title to necessary lands and property by donation, devise, bequest or condemnation proceedings for the purpose of establishing or completing said parks and recreational grounds, and

WHEREAS, said Chapter 194 further authorizes the Board of County Commissioners of Douglas County, Kansas, to buy land and furnish materials for dams, spillways, roads and such other improvements as may be conducive to the recreation, convenience and comfort of the public as such Commissioners may deem necessary, and

WHEREAS, said Chapter 194 empowers the Board of County Commissioners of Douglas County, Kansas, to issue and sell bonds of said County for the purchase, establishment and completion of a public park and recreational grounds as aforesaid in an amount not exceeding one-tenth of one per cent of the total amount of assessed valuation of said county for the fiscal year next preceding the issuance of such bonds and such bonds may be issued and sold without the necessity of an election unless a petition in opposition to the issuance of such bonds without an election signed by not less than twenty per cent of the qualified electors in said county shall be filed with the County Clerk of the County within thirty days following the passage of a resolution by the Board of County Commissioners declaring their intention to acquire title to lands for the purpose of park and recreational grounds.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, that the said Board intends to acquire lands known as the Lone Star Lake located in said County, by purchase or condemnation and furnish material for dams, spillways, roads and additional lands and such other improvements deemed necessary for a public park and recreational grounds for Douglas County, Kansas, at said location at a cost not to exceed \$15,000 to be financed by a bond issue as provided under the aforesaid law not to exceed \$15,000.

BE IT FURTHER RESOLVED that a copy of this resolution be published in the official County paper for three consecutive weeks to advise the electors of Douglas County, Kansas of the passage of this resolution.
