

complete parks and recreational grounds within said county and may purchase or acquire title to necessary lands and property by donation, devise, bequest or condemnation for the purpose of establishing or completing said parks and recreational grounds, and furnish materials for improvements to such property, and

WHEREAS, the Board of County Commissioners, under this act, is authorized to issue and sell bonds for the purchase, establishment and completion of such a project in an amount not to exceed one-tenth of one per cent of the total amount of the assessed valuation of said county for the fiscal year next preceding the issuance of such bonds, and

WHEREAS, on July 16, 1937, the Board of County Commissioners of Douglas County, Kansas, adopted its resolution declaring its intention to acquire the title to lands for the purpose of establishing and maintaining a park and recreation grounds in said county and published said resolution in the official county paper of said county for three consecutive weeks on July 29, August 5, and August 12, and

WHEREAS, with the publication of said resolution said Board of County Commissioners give notice of its intention to issue and sell the bonds of said county in an amount not to exceed \$15,000 for the purpose of acquiring lands and furnishing materials for dams, spillways, roads and such other improvements as may be conducive to the recreation, convenience and comfort of the public as said Commissioners may deem necessary and to employ engineers to prepare plans and specifications for such improvements and make estimates of the costs thereof unless a petition, in opposition to the issuance of such bonds without an election, signed by not less than 20 per cent of the qualified electors of said county be filed with the County Clerk of said county within thirty days after the 12th day of August, 1937, and

WHEREAS, protests in opposition to said project and signed by not less than 20 per cent of the qualified electors in said county have not been filed with the County Clerk of said county within said 20 day period as provided by law, and it is deemed necessary and expedient by said Board that Douglas County, Kansas, now issue its negotiable bonds for said project aforesaid;

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Douglas County, Kansas, in meeting duly assembled:

Section 1. That for the purpose of providing funds to pay the cost of acquiring title to lands for the purpose of a public park and recreation grounds and for improvement of the same, there are hereby authorized the total principal sum of \$15,000 of Park Bonds of said Douglas County, Kansas. Said bonds shall be dated August 15, 1937, shall be numbered from One to Thirty, inclusive, in the denomination of \$500 each.

Section 2. Said bonds shall become due serially as follows:

Section 3. Said bonds Nos. 1 to 15, both inclusive, shall bear interest at the rate of 2½ per annum, bonds Nos. 16 to 30, both inclusive, shall bear interest at the rate of 2½ per annum, payable on the fifteenth days of February and August of each year after the date of issue. Said bonds shall be signed by the Chairman of the Board of County Commissioners, and attested by the County Clerk, under the seal of the County, and the interest coupons may be authenticated by the facsimile signatures of the Chairman of the Board of County Commissioners and County Clerk and said signatures are hereby ratified and confirmed as the signatures of said officers, and said bonds shall be registered by the County Clerk of Douglas County, Kansas, and by the Auditor of the State of Kansas.

Section 4. Said bonds, the interest coupons, and the certificates on said bonds shall be in substantially the following form:
